





POINTS TO REMEMBER- SELECTING A GOOD TRADEMARK

- ☐ Distinctive capability- Coined or Fanciful and Arbitrary
- ☐ Should not describe the goods or services

☐ Cannot be a term or word that is customary in the current language or in the bona fide and established practices of the trade.



DONT'S

- ☐ Violates any religious sentiments
- Contains Scandalous or Obscene matter

Prohibited marks

☐ International Non-proprietary names (in case of pharma products)



EXCEPTIONS

- If the trademark has acquired distinctiveness before the filing of Applications due to extensive usage.
- If it is a well-known trademark.

It has to be proved by adducing sufficient documents before the Trademarks Registry.



TRADEMARK REGISTRATION





SYMBOLS – TM, SM & R

TM & SM

- ☐ Unregistered mark.
- Not mandatory but it is wise to use
- R

- Regulated by Indian law
- ☐ Registered mark



REGISTRATION VALIDITY & RENEWAL

- Ten years
- Renewal is perpetual
- Non-filing of renewal request leads to removal of trademark from the Register.



Remedies

An infringement suit is a statutory remedy available for enforcing the rights of a registered trademark.

Civil Remedies-

- a) Injunction
- b) Damages
- c) Account of profits together with or without an order for delivery, or destruction or erasure of the infringing products

Criminal Remedies-

- a) Cognizable Offence
- b) Criminal proceedings can be initiated

WHAT IS THE LEGAL BASIS OF UDRP? THE DOMAIN NAME REGISTRATION AGREEMENT

6. DISPUTE RESOLUTION POLICY

You agree to be bound by our current Dispute Resolution Policy. This policy is incorporated herein and made a part of this Agreement. You can view the <u>Uniform Domain Name Dispute Resolution Policy</u> online. You agree that GoDaddy may from time to time modify its Dispute Resolution Policy. GoDaddy will post any changes to its Dispute Resolution Policy at least thirty (30) days before they become effective. You agree that by maintaining your domain name registrations with GoDaddy after the updated policy becomes effective that you agree to the Dispute Resolution policy as amended. You agree to review GoDaddy's website periodically to determine if changes have been made to the Dispute Resolution Policy. UDRP

The registration of the domain name will not infringe upon or otherwise violate the rights of any third party

Not registering the domain name for an unlawful purpose Not knowingly use the domain name in violation of any applicable laws or regulations


ESSENTIALS- OF UDRP ACTION

demonstrate that the domain name is identical or confusingly similar to a trademark or service mark in which the complainant has rights; <u>AND</u>

prove that the registrant lacks rights or legitimate interests in the domain name; **AND**

establish that the registrant has registered and uses the domain name in bad faith

- Kotak Mahindra Bank Limited v. Richard Brown [2008] www.udaykotak.com
- The uncontradicted evidence of the Complainant in this case is that the commercial community identifies the Complainant with the bank which he founded and which Kotak Mahindra Bank Limited continues to operate under his leadership. He is seen by the media and the public, particularly in India, as the alter ego and driving force behind the company. He retains a substantial shareholding. He is identified with its achievements. The enterprise has a clear interest in protecting his name for commercial use, in view of the Complainant's association with the bank and the fact that it trades under its registered mark KOTAK, his surname.

Service Provider engaged to register. Who engages a person in Canada (Renji Mathew) to register

Canadian registers in individual name. Refuses to transfer, seeks compensation.

Long drawn correspondence entered into to establish bad faith. UDRP filed and ordered to be transferred. (2017)

UNMAIL.COM

Complainant adopted the mark in 2015. Domain registered by Respondent in 2013.

Respondent alleges reverse domain name hijacking by Complainant.

Appears that employee of complainant has approached Respondent for acquisition prior to the complaint, in 2015.
