As per Prevention of Sexual Harassment Act, 2013, there are 2 reports to be submitted by the employer:

- It is the duty of the ICC to submit an annual report, which includes the number of cases filed/disposed of every calendar year to the employer and district office.
- The employer has a statutory obligation to ensure this report is included in the annual report of the organization filed to the Registrar of companies.

What are the duties of an employer?

The law has provided for several duties of the employer. Such duties begin at the time when an employer has to set up an internal complaints committee to ensure that aggrieved can file their complaints and seek redressal to such complaints and end at the time when the employer has provided certain data, in accordance with the provisions of the law, in relation to sexual harassment in its annual report.

There are several other duties of an employer under the law, some of which are provided below:

- (a) Organise workshops and awareness programmes at regular intervals for sensitising the employees with the provisions of the Act and orienta tion*
- (b) programmes for the members of the Internal Committee. With respect to workshops and awareness programs, it says that employer

Formulate and widely disseminate an internal policy or charter or resolution or declaration

PENALTIES UNDER THE ACT

- 26. Penalty for non-compliance with provisions of Act.
- 1. Where the employer fails to-•
 - a. constitute an Internal Committee under sub-section (1) of section 4;
 - b. take action under sections 13, 14 and 22; and
 - c. contravenes or attempts to contravene or abets contravention of other provisions of this Act or any rules made there under, he shall be punishable with fine which may extend to fifty thousand rupees.
- 2. If any employer, after having been previously convicted of an offence punishable under this Act subsequently commits and is convicted of the same offence, he shall be liable to-CO twice the punishment, which might have been imposed on a first conviction, subject to the punishment being maximum provided for the same offence:
- i. Provided that in case a higher punishment is prescribed under any other law for the time being in force, for the offence for which the accused is being prosecuted, the court shall take due cognizance of the same while awarding the punishment:
- ii. Cancellation, of his licence or withdrawal, or non-renewal, or approval, or cancellation of the registration, as the case may be, by the Government or local authority required for carrying on his business or activity.


