The scheme is named as YUVA Corporate Membership Scheme of NIRC-ICSI.

The YUVA Corporate Membership Scheme for young members of NIRC of ICSI is open for members of the Institute from Northern Region, who have been awarded the membership on or after 1st January, 2019 and is open for the Year 2023-24 (October, 2023 to March, 2024)*.

***NIRC-ICSI has decided to implement the scheme for 6 months (October, 2023 to March, 2024) only, with reduced charges for financial year 2023-24.**

Members may note that only 100 members will be enrolled for the YUVA Corporate Membership Scheme on first come first serve basis. Members Opting for the YUVA Corporate Membership Scheme shall be entitled to the following benefits:

- Separate Programs will be organised under this Scheme. (Venue of the all such programs will be Auditorium of NIRC).
- Minimum 6 Programs will be organised under this Scheme on the topic of Professional interest

and soft skills.

- Members will be entitled to attend all the paid programs as may be organised by NIRC for Young Members by self only at NIRC Auditorium, ICSI- NIRC Building free of charge throughout the year 2023-24 (October, 2023 to March, 2024) proxy is not allowed.
- Credit hours will be given to only those members who join the Programs within half an hour of starting of Program.
