New Foundation Course

level to Profession

CS FOUNDATION NEW COURSE



As expected the ICSI has announced a new syllabus and OMR based exam pattern for its CS course. As per a web release ICSI has stated that

"The Foundation Programme being the entry level to the Company Secretaryship Course and gateway to the profession of Company Secretaries, the Syllabus Review Committee based on the feedback received from various stakeholders has completed the formulation of detailed contents of the Foundation Programme.

Chapter is pleased to inform you that the Council of the Institute has approved the new syllabus for the Foundation Programme."

Salient Features and Requirements

The salient features of the new syllabus and the changed pattern of conducting the examinations for the same is summarized below :-

1. Effective date for New Syllabus

- The new syllabus of Foundation Programme will be effective from 1st February, 2012.
- 2. There are four subjects under the new syllabus viz.
 - Business Environment and Entrepre neurship;
 - Business Management, Ethics and Communication;
 - Business Economics;
 - Fundamentals of Accounting and Auditing.

2. New Pattern of Examination

Keeping in view the tech-savvy new generation and with a view to leverage the information technology, the Council of the Institute has decided to conduct Optical Mark Recognition (OMR) based Examination (Objective Type Multiple Choice Questions) for the Foundation Programme under the new syllabus.

3. First Examination

First examination under this new syllabus will be held from December 2012 session of CS examinations.

4. Option to students under existing syllabus

- Students who have registered prior to 1st February, 2012 (subject to the validity of their registration) will have option to continue with the existing syllabus till June, 2013 Session.
- From December, 2013 session, all students will be automatically switched over to the new syllabus.
- In other words, from December, 2012 to June, 2013 session of examination both syllabi (existing syllabus as well as new syllabus) will run parallel.



5. Switchover to new syllabus

- (i) Students under the existing syllabus may switch over to the new syllabus. They may exercise their option to switch over to the new syllabus while filling up the examination form for December, 2012 session and no other formal request is required to be sent to the Institute for the purpose.
- (ii) Students switching over to new syllabus will not have to pay any charges other than the cost of Study Materials under new syllabus, if any, to be purchased by them.
- (iii)Students of existing syllabus are NOT eligible for any paper-wise exemptions on switching over to the new syllabus and they will have to appear in all the papers under the new syllabus irrespective of their performance in previous sessions of examinations or any other qualifications.

All the information about the same is available on the institute's site.

We hope that the new Foundation course shall bring more strength to the entry level professional students. Further details are available at the Website.

CARBON CREDIT: A NEW DIMENSION OF ACCOUNTING AND TAXATION METHOD

INTRODUCTION

The term 'Carbon Credit' has been coined in response to the concern of global warming and climate change. One of the major reasons for global warming is the failure of ozone layer to protect the earth's atmosphere from ultra -violet rays. This failure is because of industrial pollution and some substances being emitted in the atmosphere by virtue of human activities. This global warming cause many changes in the climatic conditions that will make our earth unfit for living. Such disturbances are causing unusual changes like frequent storms, floods, earthquakes, droughts, crop failures, scanty rainfalls, rising sea levels disappearing of islands and coastal areas and many other irreparable damages.

In 1997 world submit in relation to global warming held in Kyoto, Japan evolved the concept of Carbon Credit to mitigate emission of greenhouse gases which causes negative climatic changes. Carbon credit is a tool being used for reducing emission of pollution in the atmosphere by giving it a monetary value.

WHAT ARE CARBON CREDITS?

Each carbon credit represents one tone of Carbon Dioxide either removed from the atmosphere or saved from being emitted. Carbon credits are issued as Certified Emission Reduction (CERs) by the UNFCCC. The CERs are certificates in fungible form which can be traded in any of the following emission markets:

- European Union Emission Trading System (EUETS) Multi Country Trading Scheme.
- Chicago Climate Exchange (CCX) North America.
- European Climate Exchange (ECX) Europe.
- Nord Pool Norway, Denmark, Sweden and Finland.
- Powernext, a Paris based company operating a European energy exchange, owned by NYSE Euro next.
- Multi Commodity Exchange (MCX) India.

A FEW ACTIVITIES ELIGIBLE FOR CARBON CREDITS

- Some of the activities that are eligible for availing of carbon credits include-
- Afforestation and reforestation projects.
- Agri-biomass based energy projects.
- Energy generation by controlled combustion.
- Household level biogas plants treating organic farmyard kitchen and bio-wastes.
- Solar Energy.

ACCOUNTING FOR AND TAXATION OF CARBON CREDITS A NEW DIMENSION ADDED

Generation of revenue by taking up structural Clean Development Mechanism (CDM) projects would give a new dimension to Accounting and Taxation. As the concept of carbon trading is new, even at international level, various aspects and jurisprudence are yet to evolve. The Council Institute of Chartered Accountants of India has approved of the accounting guidance note on carbon credit effective from July 1, 2009. As per the guidance note, the self-generated carbons credits are "intangible assets" and they need to be treated as "inventory" in the balance sheet till they are sold. As



per AS-2, Carbon Emission Rights (CERs) should be measured at cost or net realizable value, whichever is lower.

Regarding tax treatment of CERs, no directive has been issued by the Income-tax department. Since most of the Clean Development Mechanism (CDM) projects are covered in infrastructure sectors like power plants, renewable energy projects, etc., such projects enjoy tax

CERs may be considered **as** good for VAT purposes and be treated similar to electricity – which is either excludes from purview of VAT or included in the "Schedule" of goods exempted from VAT in order to promote CDM projects in India.
