	The Companies Act 2013 is set to replace the nearly six-decade old regulations that govern corporates in the country.
1	98 sections of the New Companies Act has already been notified on September 12, 2013 and given effect to.
	MCA had also put up draft rules under the New Act for public comments which is expected to be finalised soon.
-	The Companies Act 2013 has added significance to the manifold role of Company Secretaries, in view of which ICSI-CCGRT is organising this program.
