(a) The Government of India promulgated an ordinance declaring existing unregistered associations dealing in foreign exchange (FOREX) as illegal without registration. The ordinance was published in Official Gazette dated 22<sup>nd</sup> August, 2015, which was its effective date.

One, Raman Associates located at Shop No. 444, Khan Market, New Delhi, was carrying on FOREX business since 1990. It was unregistered. Its five members procured business from nearby four-star, five-star hotels. Other three members processed the transactions in liaison with banks. One member, Manish looked after office paper work and the premises only. In fact, he was just a clerk and *daftri* but shown as a dummy member. After 24<sup>th</sup> August, 2015, Raman Associates wound-up their business. Its members disappeared leaving the premises behind, in charge of Manish.

On 26<sup>th</sup> September, 2015, Delhi Police raided the shop and arrested Manish on charges of dealing in FOREX. The order of District Magistrate, Delhi, was served on him. All his pleas that he never dealt in FOREX and was unaware of the ordinance or whereabouts of other members, fell flat. He was put in judicial custody as under trial in Tihar Jail.

Suresh, his elder brother, contacted the Delhi State Legal Services Authority office in the Delhi High Court complex. Their consultant, a mediation judge, advised him to move Delhi High Court, for Manish's release from unconstitutional detention.

Draft appropriate writ petition with the above facts. Assume any supplementary data.
