

- * Company Secretary is an indispensable professional in the efficient management of an organization, whose affairs are conducted by the board of directors or a Council or any other corporate structure.
- ❖ In fact, a Company Secretary is a senior managerial person in the corporate structure ensuring administration of the Company and certifying the company's compliance with the provisions of the various acts and statutes.

Appointment of "key Managerial Person"

- ❖ Inclusion of CS in KMP in Companies Bill,2012.
- *As per clause 2(51) of the Bill, the definition of KMP includes a Company Secretary apart from MD, CEO and CFO.
- Appointment of KMP as per clause 203 of Companies Bill ,2012 :
 - Every Company belonging to such class or classes as may be prescribed shall have the following Whole Time "Key managerial Person" -
- ✓ Managing Director or CEO or Manager and in their absence;
 a whole time Director;
- √ Company Secretary;
- ✓ CFO



Companies Bill 2012 & Company Secretary





Scope for Company Secretaries in Companies Bill, 2012

* Incorporation of Company -

- ✓ For incorporation of a Company there is a requirement that
 a declaration is to be given by a Company Secretary.
- ✓ Company Secretary, who is engaged in formation of the company that all the acts and rules have been complied with.

*Annual Return-

- ✓ Section 92 of the Bill contains provisions about Annual Return of the Companies
- ✓ A Company Secretary has to sign and certify the correctness of the annual return of the Company.

Scope for Company Secretaries in Companies Bill, 2012

- Secretarial Audit Introduced under Clause 204 of the Bill -
- ✓ A Company has to Co-ordinate the performance of a Secretarial audit, Performed by a Company Secretary in Practice.
- ✓ The Secretarial Audit report has to be annexed with the Director's and Auditor's report.
- ✓ The Board of Directors, in their report shall explain in full any qualification or observation or other remarks made by the company secretary in practice in his report.


Factors for the Growth of the Profession
