#### Remuneration of Faculty at entry of the Scheme

Existing faculty members at the Class Room Teaching Centres at Regional Offices shall be eligible for remuneration of Rs. 3.00 per minute and faculty members at Class Room Teaching Centres at Chapter Offices shall be eligible for a remuneration of Rs.2.50 per minute. All others shall be eligible for a remuneration of Rs.2.00 per minute.

The increase / decrease in remuneration thereafter shall be based on the feedback of stakeholders which shall be kept confidential. In any particular month, the maximum increase/ decrease shall be of 50 paise per minute. No request for increase / decrease shall be entertained from the faculty as the same shall be purely based on the feedback.
