About scheme:

The details of the Scheme are as follows:

Benefits of the scheme:

1. All Programs exclusively organised by Indore chapter between **01st April, 2024 to 31st March, 2025** will be covered under this scheme (except program mentioned below).
2. Any one authorized person is eligible to attend the program under Category B on behalf of corporate/PCS firm.
3. Complimentary Library Membership Subscription.

Validity: The Membership is valid for the period from **01st April, 2024 to 31st March, 2025**.

Note: - PMS Scheme not applicable for Joint Programs/ National Level Programs/ Regional or State Conferences/ Residential Programs / two days Conference/ Workshops/ Non-Academic programs or any other programs specified in the brochure of the program.

However, Indore Chapter may, at its sole discretion, from time to time, announce the discount on fees for PMS members for Joint programs subject to confirmation from competent authority.

Payment Mode: - **Payment** of PMS by way of Cheque in favor of "ICSI Indore Chapter". Members can also make online payment as per following details:

Corporate/PCS Firm Membership:

Upto Three names (Partner/Employee) of same firm/corporate required at the time of PMS registration of corporate entities/PCS Firms/LLPs. Kindly note at a time **only one Authorized person from this category whose name given in registration form** will be allowed to attend the program.

Terms and conditions:

1. **Fees of PMS once paid will not refundable nor transferable.**
2. **Last date of Registration in this scheme is 15th May, 2024.**
3. Register for the scheme at an early date to avail the maximum benefit.
4. PMS members shall be required to register for a program in advance till the date given in the circular/flyer of the program. Spot registration shall be allowed to PMS Members, strictly on a "First come; First serve basis", subject to the availability of seats, however, it is not guaranteed.
5. Credit hours will be subject to the physical in & out attendance in each program. Continuous Professional Education (CPE) Credits would be granted to member(s) attending the program as per the guidelines of the ICSI,
6. GST number of ICSI Indore Chapter is **23AAATT1103F2Z7**. For claiming input credit, kindly provide GST Registration certificate alongwith registration form.
7. This scheme does not valid at any other chapters of ICSI.
8. ICSI (Continuous Professional Education) Guidelines are applicable on all such program as may be orgnised under this scheme also.
9. Once the registration of the PMS Scheme is done, then it is deemed to have consented to these terms and conditions of PMS-2024 of ICSI Indore Chapter.
10. No benefit under any other scheme such as CSBF discount for members shall be applicable to the members/firm subscribing to this scheme.
11. Decisions of the Chairman-Indore Chapter and Chairman-PDC, Indore Chapter shall be final and binding on PMS Subscribers with respect to all matters related to the scheme.
