The Speaker during the session informed the gathering on IBC, Key Features of IBC and informed that The Insolvency and Bankruptcy Code, 2016 is a code which aims to consolidate and amend the laws relating to insolvency resolution of companies and limited liability entities, partnerships and individuals, which are contained in various enactments, into a single legislation. She informed that the main focus of this legislation is at providing resurrection and resolution in a time bound manner for maximization of value of debtor's assets. She informed that the Code has put forth an overarching framework to aid sick companies to either wind up their business or engineer a revival plan, and for investors to exit. Notably, the Code has also empowered the operational creditors (workmen, suppliers etc.) to initiate the insolvency resolution process if default occurs. The Speaker has presented various examples on IBC before concluding the session.
