Report on Full Day Joint Conference in association with BCIC on The Companies (Amendment) Act, 2017 and Kotak Committee Recommendations on Corporate Governance - March 16, 2018

















The ICSI-Bengaluru Chapter and Bangalore Chamber of Industry and Commerce (BCIC) organised a Joint Conference on The Companies (Amendment) Act, 2017 and Kotak Committee recommendations on Corporate Governance - March 16, 2018 at Hotel ITC Gardenia, Bengaluru.

Mr. N Venkatakrishnan, Chairman, Banking, Finance and Corporate Affairs Expert Committee, BCIC did the welcome address for the conference.

CS Gopalakrishna Hegde, Council Member, ICSI, while setting the context informed that 2nd June 2017 SEBI has constituted Committee appointing Mr. Uday Kotak as Chairman with 28 Members, and 4 months that is on 5th October 2017 the committee has handed over their recommendations to SEBI which was posted by SEBI on its website for Comments from stake holders. The observations made by stake holders towards the recommendations were mentioned as more disruption of business than game changer.

Dr. K S Ravichandran, Managing Partner, KSR & Co Company Secretaries LLP in his address on Overview - New Companies (Amendment) Act 2013 stressed on the requirement of E Tribunals and E Companies Act.

CS Makarand Lele, President, The ICSI in his address informed that "E" is the need of the hour and if everything becomes E then CS will also have to become ECS. He said down the line in another 5 years artificial intelligence will enter CS Profession where in Company Secretaries in the Company System will talk to MCA System and submit information and do compliances. He later informed the gathering on all the latest initiatives taken by ICSI.

Mr. M R Bhat Regional Director, Registrar of Companies, South East Region, Ministry of Corporate Affairs, Govt of India in his address congratulated both BCIC and ICSI for organising the event and informed that this Conference focuses on key technical aspects which have seen major changes. The sessions are structured into two broad themes —Recent amends in Companies Act and Kotak Recommendations on Corporate Governance to enable better appreciation of the legislative intent and changes. Practical issues from industry stand point as well as an objective assessment from a practitioners' perspective.

Report on Students Study Circle Meeting – 25th March 2018

The ICSI-Bengaluru Chapter organised Students Study Circle Meeting on 25th March 2018 at the Chapter Premises.

The Study Circle Meeting was presided by Speaker CS Shruthi B N, Practicing Company Secretary, Bengaluru who took session on topic LLP Formation, Basics and Compliances wherein the speaker informed the gathering on procedures for formation on LLP, and informed minimum of two Partners are required to start the LLP formation procedure and a registered office location is required within India. She informed that it is important to remember that FDI in LLP is allowed only with the prior approval of the Reserve Bank of India (RBI). The speaker then informed that all LLPs registered with the Ministry of Corporate Affairs need to file Annual Returns and Statement of Accounts for every Financial Year. It is mandatory for a LLP to file a return irrespective of whether it has done any business. There are three mandatory compliance requirements to be followed by LLPs 1) Filing of Annual Return 2) Filing of Statement of the Accounts or Financial Statements 3) Filing of Income Tax Returns.
