Explaining on Registration of projects with RERA the speaker informed the Projects covered are Commercial, residential, plotted developments, ongoing projects where completion certificates not issued are also covered.

The Speaker then explained the impact of RERA on developers, customers, real estate, structure, taxation, etc before concluding his session.

The 2nd Technical session was taken by CA Sandeep Jhunjhunwala, Associate Director, BMR Associates, LLP on topic The Insolvency and Bankruptcy Code, 2015. The Speaker started his session by explaining the features of Bankruptcy Code, the legal frame work, Liquidation process, Insolvency resolution process for corporate debtors, Insolvency resolution process for non-corporate debtors, India's Bankruptcy laws etc before concluding his session.
