# Report on Full Day Seminar on Insolvency and Bankruptcy Code 2016 – 8th April 2017

















The ICSI-Bengaluru Chapter organized full day seminar on Insolvency and Bankruptcy Code 2016 on 8<sup>th</sup> April 2017 at the Chapter premises.

The Seminar was presided by CS Gopalakrishna Hegde, Council Member, The ICSI, CS Vasanth Kumar, Chairman, The ICSI-Bengaluru Chapter, CS Pradeep B Kulkarni, Secretary, The ICSI-Bengaluru Chapter.

CS Vasanth Kumar, Chairman welcomed the gathering and informed The Insolvency and Bankruptcy Code, 2016 ("Code") is the bankruptcy law of India which seeks to consolidate the

existing framework by creating a single law for insolvency and bankruptcy. The Code outlines separate insolvency resolution processes for individuals, companies and partnership firms.

The Code has tremendous potential that could help our Indian economy to overcome this issue of NPAs and to provide a free and easy flow of credits in Indian markets.

CS Gopalakrishna Hegde, Council Member, The ICSI during his address informed, The Insolvency and Bankruptcy Code, 2016 ("Code") has provided professionals a launching pad to deal with the insolvency/ liquidation process for individuals, firms and corporates. The new Insolvency law endeavours to provide a speedy and time bound mechanism to deal with the insolvency and liquidation proceedings.

# 1<sup>st</sup> Technical Session:

The 1<sup>st</sup> Technical session was taken by Mr. Sreejith K, DGM, Dena Bank Ltd on topic "Insolvency and Bankruptcy Code, 2016 – Bankers Perspective, where in the speaker informed the gathering on **Consolidation** of the laws relating to Insolvency, **Timelines** for completion of insolvency resolution process, **Resolution Professionals** – manage and control the affairs of the Corporate Debtor, **Committee of Creditors** – Decisions by CoC representing 75% of the outstanding financial debt, **Distribution of Assets** - Government dues subordinated to Secured Creditors' Dues, **Institutional infrastructure** – Establishment of IBBI, Insolvency Professionals & Entities, Information Utilities, NCLT, NCLAT etc, **Penal provisions** – For concealment, contraventions etc before concluding the session.

But from the imperfection of the language, it is often impossible to know what that intention is, without inquiring further. To ascertain the true meaning with certain rules and presumptions. The speaker then informed the participants on Intention of Legislature, General Scope of The Statute, Purposive Rule and the Mischief Rule/ Haydon's Rule, rules of interpretation etc before concluding the session.

# Students Study Circle Meeting on Evidence Specific Relief and Limitation Act- 9th April 2017

The ICSI-Bengaluru Chapter organized Students Study Circle Meeting on 9<sup>th</sup> April 2017, at the Chapter Premises. The program was presided by CS Manoj Shah, Senior Manager- Legal, HDFC Ltd, who took session on topic "Evidence Specific Relief and Limitation Act".

The speaker during the session informed the participants that as per Sec-3 of the Indian evidence act, 1872 which reads evidence as all statements which the court permits or requires to be made before it by witnesses, in relation to matters of facts under inquiry – such statements are called oral evidence. All documents produced for the inspection of the court – called documentary evidence. This interpretation is not exhaustive as it does not cover 'material objects' like, photos, weapon used in murder, bloodstained clothes etc. which are admitted in practice. He then informed the participants on objective law of evidence, classification of evidence, Proof of content of Documents, Extent and Application of the Act 1872, The Indian evidence Act 1872, Salient features of limitation act and specific relief act before concluding the session.
