He mentioned that India is one of the bright spots of development with increasing GDP growth, controlled current account deficit, increasing FDI reserves etc, and the 21st Century belonged to India. He urged that the professionals like Company Secretaries should

Technical Session – I Companies Act, 2013 – Recent Changes

CS. Technical Session – III PART 1 - GST – Implications & Opportunities

Technical Session – IV

NCLT - Advocacy Skills; Courtroom Etiquette
