This would effectively dissolve the Company Law Board (CLB) as constituted under the Companies Act, 1956 from the same day. The NCLT will start functioning with eleven Benches – two at New Delhi and one each at Ahmedabad, Allahabad, Bengaluru, Chandigarh, Chennai, Guwahati, Hyderabad, Kolkata and Mumbai. The Principal Bench of the NCLT will be at New Delhi. Some provisions of the Companies Act, 2013 (mainly pertaining to powers of the CLB) relating to powers of Tribunal have also been notified by the Government (which were not effective due to no constitution of NCLT) except provisions pertaining to compromise and arrangement, winding up etc.

He informed that in many sectors, no prior approval from the Government or the Reserve Bank is required for non-residents investing in India. The Government allows Indian companies to issue Global Depository Receipts (GDRs) and American Depository Receipts (ADRs) to foreign investors The GDRs/ADRs issued by Indian companies to non-residents have free convertibility outside India. He then informed the gathering on FC- GPR and Statement of assets and liabilities etc before concluding the session.
