IV	Members enrolled under the scheme would be entitled for 6 Programs with validity of 12 months from the month of registration. This scheme is only for outstation members with free hostel facility for 1 day on twin sharing basis	9,500/-	Actual Price is 1300 x 6 = ₹.7,800/- + Hostel Charges ₹.6,000/-, So Saving is ₹. 4,300/-

General Terms and Conditions

Sr. No.	Particulars
1.	Fees once paid cannot be refunded or adjusted or carry forward.
2.	For each program only one participant will be generally allowed for attending the program. If the program is to be attended by more than one person prior permission of the Director / competent authority is required.
3.	If the program is of 2 or 3 days, each day will be counted as one program.
4.	If the program is conducted other than CCGRT building (i.e. in hotels / IMC Hall etc), the difference in cost will be charged from the participant (i.e. to be borne by the participant) ranging between ₹. 1,000/- to ₹. 1,500/-.
5.	Half day program will also be counted as 1 program.
6.	ICSI-HO Programs will not be considered in this scheme.
7.	Only participants attending the program would be entitled to the applicable credit hours and background material
8.	Membership will commence from the month in which the payment is made
