Guidelines for Authors

- Original papers are invited from Company Secretaries in employment & practice, Academicians, Research Scholars and other Professionals.
- The paper must be accompanied with the author's name(s), email ID, and contact number along with the title of the paper on the front page.
- Full text of the paper should be submitted in MS Word using Times New Roman, font size 12 on A4 size paper in 1.5 spacing, with a maximum of 2500-3000 words.
- The full-length research paper / article should be preceded by an abstract of 200 words with maximum five key words. The author can also provide JEL (Journal of Economic Literature) Code.
- The text should be typed double-spaced only on one side of A4 size paper in MS Word, Times New Roman, 12 font size with one-inch margins all around.
- The author/s' name should not appear anywhere else on the body of the research paper / article to facilitate the blind review process. The research paper should be in clear, coherent and concise English.
- Tables / Exhibits should be numbered consecutively in Arabic numerals and should be referred to in the text as Table 1, Table 2 / Exhibit 1, Exhibit 2 etc.

- All notes must be serially numbered. These should be given at the bottom of the page as footnotes.
- The research papers / articles should reach on or before 08th of May, 2017 by 12 noon (IST).
