The legal framework for insolvency resolution in India underwent a structural change when the Insolvency and Bankruptcy Code was passed in May 2016. Cases have already started piling up at the National Company Law Tribunal (NCLT), the quasi-judicial tribunal vested with adjudication powers under the Code. It is expected that in the coming times, such cases are going to increase manifold, in the backdrop of prevailing unfavourable economic conditions.

There are many areas of the Code which need clarity. This has already manifested in Supreme Court staying the proceedings under the Code in the case of Jaypee Infratech Ltd. which was already admitted by NCLT for resolution and in which an Interim Resolution Professional was appointed and the powers of the Board of Directors of the company stood suspended.
