Earlier corporate reporting was being focused mainly on the financial performance of Companies. With the advent of Companies Act 2013, there is a statutory obligation on the corporates to take initiatives towards social, environmental and economic responsibilities and reporting it to the Company and other stakeholders appropriately. To address this concern, Security Exchange Board of India (SEBI) has mandated the Business Responsibility Report (BRR) requirement under the Listing Obligation and Disclosure Requirements (LODR), 2015 for top hundred listed companies, which has from this year onwards, been extended to top five hundred listed companies. The other Companies may also voluntarily follow guidelines and include the BRR in their Annual Report for making disclosures to their stakeholders.

Therefore, corporates should seize this opportunity to embed sustainability initiatives in their organizations as it results in increasing their stakeholders' confidence.
