

ATTENTION PROFESSIONAL PROGRAMME (OLD SYLLABUS) STUDENTS!

COMPULSORY SWITCHOVER OF ALL PROFESSIONAL PROGRAMME (OLD SYLLABUS) STUDENTS

It is informed that June, 2016 Session was the last examination for Professional Programme (under Old Syllabus). From December, 2016 Session onwards, all students under Professional Programme (Old Syllabus) shall be compulsorily required to switchover to Professional Programme (New Syllabus). As a result, there will NOT be any scope for enrolment for exam for December, 2016 under old syllabus.

Therefore, all Professional Programme(Old Syllabus) students are advised to switchover to New syllabus (by logging to account at www.icsi.edu), so that the records are duly updated before the commencement of enrolment process for December, 2016 examination. If the concerned students fail to make switchover to new syllabus, there will be serious disruption in the on-line enrolment process.

As part of the switchover process, all such students are required to exercise the option for Elective Subject (one out of the Five Available Options) under Module-3 of Professional Programme (New Syllabus).
