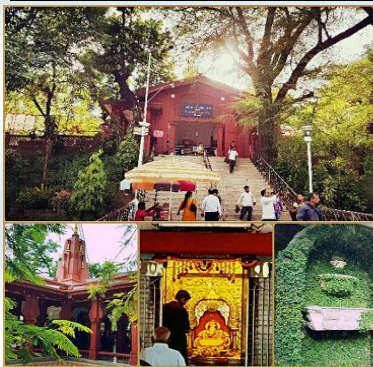
Dear Professional Colleagues,
