PROCESS OF PARTICIPATING IN THE EVENTS DURING YUVOTSAV-2024

A. GENERAL RULES

- 1. Date of Main Event is 12th January 2024 (Friday).
- 2. Prelims & off-stage events will be held on 11th January, 2024 onwards. Please keep track of updated event schedule.
- 3. Venue will be finalized shortly. Exact location will be intimated separately.
- 4. 23 events/Competitions will be held during Yuvotsav-2024.
- 5. In total there are 72 Chapters and 4 Regional Offices, so maximum number of teams for any event may be 76 teams.
- 6. The students who do not fall under the jurisdiction of any Chapter may participate as students of concerned Regional Office.
- 7. For participating in various events / competitions, every Chapter/Regional Office will get 1 point and for securing 1st/2nd/3rd position the winning Chapter/Regional Office will get 5/4/3 points respectively other than participation points. Accordingly there will be a huge All India Score Card. The complete tabulation will lead to various awards. Besides, **Fit Student Fit ICSI**: BMI (Body Mass Index) of all student participants shall be measured and students having BMI in normal range shall be awarded 2 bonus points extra in the overall score sheet.
- 8. Awards like Winner Region (First Best) and Winner Chapters (First Five) will emerge as a winner for trophies, individual winners and contestants of all competitions will also get medals and certificates of winning/participation.
- 9. All student participants & student attendees will also get certificate of participation.
- 10. Contesting in the competitions will be allowed only through the concerned Chapter/Regional Office. Chapter/Regional Office may internally conduct the competitions for their students and send nominations for the competitions in the prescribed Nomination Form (Annexure A). Without nomination form, no participation will be considered.
- 11. The nominated contestants must reach the venue (to be intimated shortly) on 11th January, 2024 by 9 a.m. In view of that, concerned Regional Office/Chapter should book their train/Bus ticket, so as their team reaches the venue (venue to be informed shortly) latest by the night of 10th January, 2024.
- 12.A "Youth March" shall be organized on 12th Jan 2024 in morning, wherein all group of students came from various ROs/Chapters shall walk with placards/posters/banners of their respective RO/Chapter.
- 13. The event will be a national level competition with participants from different states and the feeling of team spirit will be kept very high.
- 14. Stay arrangements for all students coming as participant from outstation shall be arranged in host

city and all expenses related with their stay, breakfast, lunch & dinner (during their stay in host city in connection with yuvotsav) shall be borne by ICSI-HQ. These facilities are only for the nominated contestants and not for all attendees.

- 15.If event is organized in Delhi/NCR, students coming from surrounding cities like Noida, Greater Noida, Faridabad, Gurgaon & Ghaziabad shall not be treated as outstation candidate.
- 16. Since all competitions will be organized on 11th Jan 2024 and main event will be organized on stage on 12th Jan 2024, all students coming from outstation shall be required to reach host city one day before i.e. by 10th Jan 2024 and they may leave host city in night of 12th Jan/ or morning of 13th Jan 2024 as per availability of their respective trains.
- 17. Reimbursement of travelling expenses of students
 - a.) ICSI-HQ will reimburse train fare (to & fro) of second-class sleeper (in non-AC coach) or equivalent for all students coming from outstation as "participant" to participate in Yuvotsav.
 - b.) Respective RO/Chapters are required to book train tickets of their respective group of all students together (along with the chapter staff coming with them as team in charge) and may claim reimbursement from ICSI-HQ later on after the event is over.
 - c.) Two events being Walk for a Cause and Number Game will not be considered for these facilities as no nominations are being collected in this regard.
 - d.) For attendees who are not nominated contestants, the entire event is non residential and they have to make their own arrangements.
 - e.) Contestants / Delegates / Chapters / Regional Offices may plan their travel plans at the earliest and intimate ICSI-HQ at the earliest for making necessary arrangements.
- 18.) Every contestant must be a registered delegate. The online link of delegate registration is available at the tab/icon of the event at the website of ICSI home page.
- 19.) Delegate Fees has been kept as Rs.1000/- for Students of ICSI from 21st September 2023 to 10th December, 2023. Delegate Fees for local attendees (Student of ICSI) has been kept as Rs 1000/- from 21st September, 2023 to January 5, 2024.
- 20.) Some events/competitions may be held simultaneously. Contestants will have to keep track and participate accordingly.
- 21.) Participation of students in Yuvotsav as "Participant / Attendee":
 - a.) All students who wish to participate in Yuvotsav, they should contact their respective Regional Council / Chapter to participate in their local level round of various competitions of Yuvotsav. There is no fees applicable to participate in local level competition, as these are only screening rounds.
 - b.) If they are selected by their respective RO/Chapters to represent their respective RO/Chapter in any (or many) competitions, they should register themselves as "Participant" of the Yuvotsav by paying requisite participation fees through online process.

- c.) Please note that only such students will be allowed to participate in various competitions of Yuvotsav in main program of HQ, who are officially nominated by their respective RO/Chapter to participate in respective competition. RDs/EOs/Incharge of all RO/Chapters are required to send nomination forms duly singed to ICSI-HQ as per prescribed format.
- d.) Students coming from outstation are to ensure that their name is nominated by their respective RO/Chapter to participate in the Yuvotsav as part of team representing the particular RO/chapter. Only then they will be entitled for stay arrangements and food to be provided by ICSI-HQ.
- e.) Any outstation student who is not nominated by his/her RO/chapter is not allowed to attend the Yuvotsav or participate in various competitions of Yuvotsav in his/her individual capacity.
- f.) Only local students who belong to host city shall be allowed to attend the Yuvotsav as "Attendee", even if they are not nominated by their RO/Chapter to participate in the various competition of Yuvotsav on behalf of their RO/Chapter students. For that, they all will be required to register themselves as "attendee" by paying requisite fees through offline process/application form designed for the same. Limit of number of attendees allowed to be registered shall depend on total available seating capacity of hall/auditorium in which event is being organized.

22.) Total Number of Participation from ROs/Chapters

- a.) Any RO or Chapter can nominate maximum 25 students, covering nominations for all competitions.
- b.) Each RO/chapter is advised to depute one official of respective RO/chapter as "Team In-charge" along with each team coming from respective RO/Chapter. He/she will be responsible to maintain control & discipline of students coming with him/her as team of his/her respective RO/chapter. He/she will be one point contact for ICSI-HQ for all Yuvotsav related matters.
- c.) If minimum 20 students are coming as "participant" from any RO/Chapter as part of their team, in such case expenses related with travelling & stay for the their team in-charge will be reimbursed by ICSI-HQ. If number of students in any team coming from outstation is less than 20, in such case expenses related with travelling & stay for their team in-charge will be borne by their respective RO/Chapter.
- d.) Chairman of RC/Chapter may also come to accompany their respective team if they so desire. If they are coming, they will be leading their respective team in "Youth March". All expenses related with travelling & stay for their Chairman will be borne by their respective RO/Chapter. If Chairman is not able to come personally, he/she is not permitted to depute any other Managing Committee member for the same.
- 23.) Rules may be changed/updated from time to time.
- 24.) Decision of Judge(s) / Organizing Committee shall be final and binding.

- (f) Enough research is required to present a good idea matching all the three aspects. Substitutes of existing products including plastic or changes in the existing business models (howthings are done) are indicative examples. Innovative products, services, ideas will be required.
- (g) Time for each contestant 2 mins. (Reminder at 1.5 mins.) refer Elevator Pitching Sessions.
- (h) Negative marking for exceeding time limit.
- (i) Order of speaking will be chosen by way of draw of lots.
- (j) Award Categories: 1st Prize, 2nd Prize & 3rd Prize
- (k) Other rules will be informed on spot.
- (I) Rules will be updated from time to time. Please keep track.
