**RESULT OF COMPANY SECRETARIES EXAMINATIONS
DECEMBER, 2021 SESSION**

The result of Company Secretaries Examinations for Professional Programme (Old and New Syllabus) and Executive Programme (Old and New Syllabus), December, 2021 Session has been declared today, i.e., the 25th February, 2022 at New Delhi and released to all the Regional and Chapter Offices of the Institute throughout the country for information of all concerned. In addition to making available the result along with subject wise break-up of marks on the Institute's website - www.icsi.edu, the ICSI has extended the facility of downloading of e-Result-cum-Marks Statement by the Examinees of Executive Programme Examinations.

In Professional Programme (Old Syllabus) Examination 35.55 percent of Candidates passed in Module – I, 28.57 percent in Module – II and 36.07 percent in Module – III, while in Professional Programme (New Syllabus) Examination 27.38 percent of Candidates passed in Module – I, 20.37 percent in Module – II and 41.26 percent in Module – III.

ADITYA SONI appeared from HYDERABAD Examination Centre and SHRUTI NAGAR appeared from INDORE Examination Centre have secured All-India First Rank in Professional Programme (Old Syllabus) and Professional Programme (New Syllabus) Examination respectively.


In Executive Programme (Old Syllabus) Examination 18.11 percent of candidates passed in Module – I and 14.57 percent in Module – II, while in Executive Programme (New Syllabus) Examination 9.64 percent of candidates passed in Module – I and 21.91 percent in Module – II.

ADITYA JAIN appeared from BHILAI Examination Centre and CHIRAAG AGARWAL appeared from KOLKATA Examination Centre have secured All-India First Rank in Executive Programme (Old Syllabus) and Executive Programme (New Syllabus) Examination respectively.

The next Examinations of Company Secretaries Executive Programme and Professional Programme will be held from Wednesday, the 1st June, 2022 to Friday, the 10th June, 2022, for which on-line submission of enrolment applications together with requisite Examination fee shall commence from 26th February, 2022. 
