**RESULT OF COMPANY SECRETARIES EXAMINATIONS  
DECEMBER, 2019**

The result of Executive Programme (Old and New Syllabus) and Professional Programme (Old and New Syllabus) of Company Secretaries examinations held in December, 2019 has been declared today, i.e., the 25<sup>th</sup> February, 2020 at New Delhi and released to all the Regional and Chapter Offices of the Institute throughout the country for information of all concerned. In addition to making available the result along with subject wise break-up of marks on the Institute's website—[www.icsi.edu](http://www.icsi.edu) the ICSI has extended the facility of downloading of e-Result-cum-Marks Statement by the examinees of Executive Programme examination.

In Executive Programme (Old Syllabus) examination 13.54 percent of candidates passed in Module-I and 16.56 percent in Module-II, while in Executive Programme (New Syllabus) examination 7.68 percent of candidates passed in Module-I and 11.95 percent in Module-II.

In Professional Programme (Old Syllabus) examination 30.11 percent of candidates passed in Module-I, 23.74 percent in Module-II and 34.26 percent in Module-III, while in Professional Programme (New Syllabus) examination 40.08 percent of candidates passed in Module-I 28.59 percent in Module-II and 31.07 percent in Module-III.

Priya G. appeared from Chennai examination centre and Kalyani Ashwin Pundlik appeared from Pune examination centre have secured All-India First Rank in Executive Programme (Old Syllabus) and Executive Programme (New Syllabus) Examination respectively.

Harshit Jain appeared from Indore examination centre and Shruti Kalpesh Shah appeared from Mumbai examination centre have secured All-India First Rank in Professional Programme (Old Syllabus) and Professional Programme (New Syllabus) Examination respectively.

The next examinations of Company Secretaries Executive Programme and Professional Programme will be held from Monday, the 1<sup>st</sup> June, 2020 to Wednesday, the 10<sup>th</sup> June, 2020.

The last date for on-line submission of enrolment applications together with requisite examination fee is 25<sup>th</sup> March, 2020.
