Eligibility criteria for admission in MSOP are as under:

- 1. The Students who have completed Professional Programme Examination and completed all training requirements to become a member of the Institute (except 15 Days Specialized Training).
- 2. The Students under Earlier and Modified Training Structures, who are required to complete MSOP are allowed to register for 15 Days CLDP through Class Room Mode. Such Students shall not be required to complete the 15 Days CLDP through Online Mode.

Eligibility criteria for admission in CLDP are as under:

- 1. All students after passing Professional Program and getting exemption or completing their Long Term training and one month EDP or exempted there from are required to undergo and complete CLDP
- 2. Under New Training structure the students who have completed 15 Days Online Mode CLDP and have a valid Completion Certificate, shall be allowed to register for 15 Days Classroom Mode CLDP.

Important Instructions:

- It is mandatory for the Students to attend all the sessions of CLDP/MSOP to get the completion certificate.
- Students are also required to submit a project report or pass Viva voce.
- The dress code for the program is Formal Attire in Sober Color
- We request you to ensure Safety & Social Distancing norms, wearing of Mask etc.
