How to Reach Venue

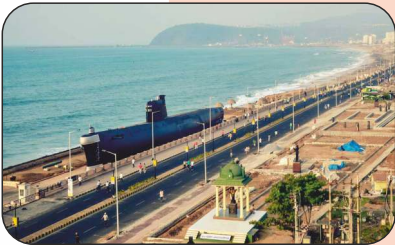
Distance from Visakhapatnam Airport to Venue: - 14 kms, taking approximately 28 minutes

Distance from Nearest Railway Station (Visakhapatnam Railway Station):- 5.1 kms, taking approximately 12 minutes

ATTRACTIONS AT VISAKHAPATNAM

Visakhapatnam, a gem of South India situated in the heart of Andhra Pradesh, is known for its picturesque beaches including the famous Rama Krishna Beach, serene landscape and a rich cultural past making it an ideal spot for a fantastic coastal vacation.

Major Attractions



INS Kurusura Submarine Museum: 1.7 kms from Novotel Visakhapatnam, the INS Kurusura Submarine museum is located on the coast of Rama Krishna beach. INS Kurusura, first submarine turned into a museum in the whole of Asia and second in the world, is a Kalvari-class diesel-electric submarine constructed by the Russians in the year 1969. It reached Visakhapatnam in 1970 via the Baltic Sea and served the Indian Navy till it was decommissioned on 27 February 2001 after 31 years of service and turned into a museum.

TU 142 Air Craft Museum: 1.7 kms from Novotel Visakhapatnam, the TU 142 Naval Aircraft Museum is also known as the “Pride for the City” and offers a delightful experience for sightseeing lovers, history buffs and experience seekers interested in learning everything about the lives of Navy people. Located on the beach road, this museum provides a chance to enter the aircraft that was earlier used for the Indian Navy.



Rama Krishna Beach: 2 kms from Novotel Visakhapatnam, it is more commonly known as the RK beach and gets its name from the Ramakrishna Mission ashram situated nearby. With its serene waters and cool atmosphere, the beach offers a wonderful view of the countryside. One can enjoy a ride in the traditional fishing boat or take a local cruise to enjoy the beautiful view of the sunset.

Borra Caves: 5.3 kms from Novotel Visakhapatnam, Borra Caves are located in the Ananthagiri hills of the Araku Valley of the Alluri Sitharama Raju district in Andhra Pradesh. One of the largest caves in the country, they are home to million-year-old stalactite and stalagmite formations. Perched at an elevation of 1,400 m above sea level, the majestic caves came into existence as a result of the flow of Gosthani river on the limestone deposits in the area.



Varaha Lakshmi Narasimha Temple: 10.5 kms from Novotel Visakhapatnam, it is a Hindu temple situated on the Simhachalam Hill Range, which is 300 metres above the sea level in Visakhapatnam. It is a well-known shrine that provides sacred and spiritual vibes to Lord Narsimha devotees and attracts tourists from all over the world with its exceptionally calm atmosphere. It is dedicated to Lord Vishnu, who is worshipped there as Varaha Narasimha.
