## Guidelines For Authors



1. The article must be original work of the author.
2. It must be an exclusive contribution for NIRC newsletter and must not have been published or sent for publication elsewhere.
3. The article should preferably have **2500-4000 words**. If subject matter of the article requires article to exceed the defined limit, it may be published in two parts as per the discretion of the editorial board.
4. The article may be jointly contributed by two or more authors.
5. Research based, case studies based and opinion based articles of practical relevance to the profession of company secretaries are welcome.
6. Reference to the original source of the matter reproduced in the article if any, should be given in the article.
7. In general, articles should be informative, analytical, and based on thorough understanding and research on the subject matter covered by the article itself and must aim at creating value to the readers and other stakeholders.
8. In case of articles based on latest statutory amendment it should present the following:
  - position of law as it stood before the amendment
  - law proposed after the amendment
  - rationale behind the amendment and the likely impact of the amendment to clearly bring out the changes in law.
9. In case of article based on latest judicial pronouncements, it should contain :
  - Gist of the case in brief and the broad arguments on both sides presented before the court,
  - The judgment,
  - The case title with citation
  - The ratio laid down by the decision,
  - The provision of law covered
  - Analysis/interpretation of the judgment from the author's point of view,
  - Concluding remarks if any.
10. Authors may contribute articles on professional opportunities under any of the following topics:
  - Corporate Governance in SMEs and Start-Ups
  - The Digital Personal Data protection Act & Related Rules
  - The Strategic Pillar : Governance & ESG
  - The Tech-Driven CS: Digital Transformation & Risk

  - Company Law Updates : Key Takeaways for CS Professionals
