WOMEN AS PRACTICING PROFESSIONALS

Women in Practice: Professionalism, Challenges and Success

Women entrepreneurs including women who are professionals face many challenges in their day-today business/ professional life. In addition to the challenges that every business face in its normal course, women face additional challenges based on some gender-based stereotypes which every successful women entrepreneur or practicing professional sail through and survive. As a practicing lawyer who started my own practice at the age of 27 and surviving till now, I can relate myself more to the day to the challenges that women face in scaling up their practice / profession.

Legal profession especially practice was always considered as a profession that is not suitable for women. Right from convincing my parents to join law college, till this day, I face challenges to survive in this profession. Completing every single day at work, despite seeing multiple gender-based reasons, excuses , conditions, and representations, itself is a success in my opinion.

After 2020, when I started employing many women in my firm, I realized that I am not alone.

When I started my practice at my later twenties, at least 3 out of 5 people with whom I wanted to have a long-term professional association asked me this question – "Will you be able to continuously support us without taking a break?" Today, many people including women are made to believe that women often take breaks at work/ profession based on their priorities.

The main challenge that we women as practicing professionals face is building a trust in such a way that it should break the gender-based barriers.

Acceptance and support from the family is the biggest challenge. Even today, people consider that women are designed to do jobs that have fixed work timings and limited scope of work. Legal profession, especially practice will never promise both. Sometimes practicing professionals like us, win the confidence by our words. But many times, we may have to do that only after we establish the confidence by way of living our words.

Many women, even today are raised with a restricted mindset that we are unable to perform few tasks and withstand in few places that are dominated by men. So, both at the time of making their decision to start private practice and at the time of surviving in profession during the initial days, they need to face tough challenges. Things will be tough till we realize that we can also equally perform in the profession breaking all the barriers.

Women in Practice: Professionalism, Challenges and Success

I have noticed two common issues among women who either practice their profession and women entrepreneurs, that influence their decision to choose practice/business.

1) Lack of financial stability, Lack of defined working hours and risks involved in profession are some popular reasons that both men and women face. In addition to this, many women are forced to quit work and have career breaks for planning family and taking care of children. Taking breaks in corporate jobs can also be covered. But if you take a break in practice, that will become very difficult, as one need to start from the scratch. These are the reasons that make women rethink many times before they practice.

I wish to share few things that helped me to successfully shape my law practice are,

1) I took practice as serious as a proper job and dedicated sufficient time at office right from day 1 irrespective of whether I have sufficient work or not. This not only helped me to have a proper routine since the beginning but also helped me to have time for myself to think and explore new avenues to build my practice. Devoting time to work need not be the time you allot to do work. It is dedicating time for work, learning, networking, branding, and everything that you do. Investing time in a proper way helps in healthy growth. 2) Considering practice as a "Free time job." I have seen this attitude with some women who choose practice just to cover the left-out time that they have after meeting their other priorities. If one start practice thinking that as an option to do after other priorities, then they may excel as a freelancer but not as a successful practitioner in long run.

2) I broke the barriers that are still prevailing in the society for women. I devoted sufficient time for networking, meeting new people, socializing etc. In addition to this, I built my personal profile by boldly voicing my opinion by way of writings. Building a personal profile especially by women helps people to gain more trust and gradually it brings more opportunities.

3) Always never hesitated any work just because it demanded more time, travel and tedious. Every new work is a new learning and we need to have confidence that our skills and hard work can make anything possible.

4) Always had my business/ practice at the top of my priority list irrespective everything that happened in my life. Even during times, I had personal setbacks, family commitments and health issues, never decided to quit or disturb my ongoing work at any cost. Top in priority list does not mean placing work at the first place always. It can also be second or third comparing to our life situations. But not more than that for sure. This is a major challenge for many women. But if we can make this, then nothing like it.

5) Having financial goals and financial independence are very important. We need to have our targets and goals set, irrespective of the fact whether we need to contribute to the family or not. Society unfortunately thinks that we women may not have individual financial commitments and sometimes we may be taken for granted. At any cost we women should not compromise on the value of our time and skills. 6) Lastly influencing other women is very important. Not every woman may be aware. Not all women have an access. Some need a starting point and some may need an initial push. Once we fairly perform in practice, it is our duty to influence other women by way of writing our views, sharing our experiences, and collaborating with women who are denied opportunities in greater platform. As a regular practice I do this in 2 ways – 1. By hiring more women at my work place and groom them to break gender-based bias and 2. Influencing more women by way of sharing my experience in social media and telling them that if it is possible for me then it can easily possible for other women.

There is always a disparity between the number of women who pursue professional qualifications and the number of women who enter practice. Similarly, there is also a disparity in number of women who commence practice and continue to successfully survive. Let us work towards breaking these barriers and ensure that practicing platform for professionals become more is gender neutral in future.


