20th ALL INDIA MOOT COURT COMPETITION 2022

RULES AND REGULATIONS

I. INTRODUCTION

Moot courts or mock trials are usually based on hypothetical cases involving emerging or unsettled areas of law.

II. AIM AND PURPOSE

- To expose students pursuing the Company Secretaries Course to the nuances of court system in India and to hone advocacy skills.
- To provide a *real-life* experience cum training in doing cutting-edge research, presenting ground breaking arguments (oral and written) and contributing to the development of jurisprudence in the concerned area of laws.

III. ELIGIBILITY

Participation is restricted to the *bona fide* – registered students of the ICSI. Students will be required to carry their Identity Cards of ICSI with them at the competition. Practicing Advocates, Chartered Accountants, Cost Accountants are not eligible to participate and the students of ICSI who have cleared all modules of Professional Programme are not eligible to participate.

IV. PATTERN OF THE COMPETITION

The Moot Court Competition will be organised at three levels.

- Chapter Level Round
- Regional Level Round
- National Round

Regional Council/ Chapter which is hosting National round may organise the national round of All India Moot Court Competition in its home city or at any city under its jurisdiction.

V. DRESS CODE

The dress code shall be formal.

- Gentlemen: White shirt, Black Trousers and Tie.
- Ladies: White Sari or Salwar-kurta, or White Shirt, Black Trousers
- The dress code is applicable to all the pleading teams.

VI. LANGUAGE

The language of the competition will be English.

VII. TEAM COMPOSITION

Each team shall consist of 2 Students (1 as Petitioner & 1 as Respondent).

VIII. REGISTRATION

Teams must register with the respective Chapter with enclosed Registration Form.

IX. ROUNDS

There will be 3 (three) rounds of the Competition i.e. Chapter Level, Regional Level Round and National Level Round.

National Round

The Winner and First Runner-up of each Regional Level competition shall compete in the National Round, which makes the total number of teams to compete at national round to eight.

X. JURY

An eminent jury comprising of three senior professionals with legal acumen and practical experience shall be constituted to adjudge top Teams. Separate jury should be constituted for each Level of competition.

XI. MEMORIALS

The following requirements must be strictly met for each level. Non-conformities will be penalized:

- Each team must prepare memorials (Petition, Reply, Rejoinder & Written Notes) for both sides, i.e. (Petitioner and Respondent).
- The briefs shall be consistent with the Company Law Rules as amended from time to time.
- Once the memorials are submitted, no revisions, supplements, or additions will be allowed.
- 3 (three) copies each of the memorials for Petitioner & Respondent + a soft copy to be submitted to the respective Chapter / Region in Charge before the two days of commencement of event. Memorials must be submitted type written as per Company Law Rules / Companies Act as amended from time to time.

Procedure for Appearance at the competition

Petitioner's Submission	15 minutes
Respondent's Submission (Counter)	15 Minutes
Petitioner's submission (Rebuttal)	15 Minutes

XII. SCOUTING:

Teams will not be allowed to observe the orals of any other team(s). Scouting is strictly prohibited. Scouting by any of the teams will result in disqualification. A team's disqualification is final and irrevocable.

XIII. SCORING AND MARKING PARAMETERS:

- Memorials will carry 30% and oral submissions will carry 70% of evaluation.
- If the memorials are found to be verbatim reproduction of each other, no points will be awarded for such memorials.
- Indicative parameters for scores on the basis of Oral Submission:
 - Knowledge of fact
 - Logic, reasoning and clarity

- iv. Deference to the court
- v. Proper and articulate analysis of the issues arising out of facts
- vi. Understanding of the laws directly applicable to the issues
- vii. Ingenuity (ability to argue by analogy from related aspects of law)

d. Indicative parameters for scores on the basis of Written Submissions (Memorials) in conformity with Company Law Rules as amended from time to time.

- i. Logical progression of ideas
- ii. Originality in analysis and arguments
- iii. Effective use of headings to outline arguments
- iv. Understanding essential legal issues presented
- v. Focus on essential (not collateral) issue
- vi. Clear, concise and unambiguous writing style
- vii. Forceful and persuasive presentation
- viii. Integration of facts into legal argument
- ix. Understanding of strengths and weaknesses of case
- x. Discussion of viable alternative argument
- xi. Understanding and analysis of authority
- xii. Proper use of citations and citation form
- xiii. Effective use of authority to support arguments
- xiv. Ability to distinguish adverse cases
- xv. Neatness, legibility, typos or format errors

XIV. ANNOUNCEMENT OF RESULTS

Regional Level Round results will be announced soon after the Competition. National Level Round results will be announced on the same Day.

XV. ANONYMITY

- a. Student counsel may introduce him / her to the Judges in the usual manner and may also state their names. However, the team's region or office or other affiliations shall not be revealed at any time to any of the Judges before the competition is over.
- b. Further, all team members and observers shall refrain from identifying a team at any time and in any manner, including, but not limited to, wearing any identifying items, such as badges, blazers or identifying material, which may indicate their region or office or other affiliation.

XVI. ACCOMMODATION AND TRANSPORT

Travel expenses for the Regional Level Round will be borne by the respective Chapters where the participants are registered as Student and the Regional Council will arrange for the accommodation only.

Transport expenses for the National Level Round will be borne by the Regional Council as per ICSI Moot Court Competition Guidelines.
