Fee for Election: The candidates will have to remit the prescribed nomination fee of by way of Demand Draft in favour of "The Institute of Company Secretaries of India", payable at New Delhi.

Elections to the Managing Committee of the Chapters shall be held on Saturday, the 17th December, 2022 in all the chapters – 'Voting by Simple Majority'.

Disciplinary Action against the Members in connection with Code of Conduct: A Member shall be deemed to have brought disrepute under item (2) of Part IV of the First Schedule of the Company Secretaries Act, 1980 if, in connection with an election to the Managing Committee of the Chapter, the Candidate is found to have contravened any of the provisions of the election Code of Conduct.

Dispute arising out of Election: In case of any dispute regarding the election, the aggrieved person may make an application within 15 days of the declaration of the result of the election to the President of the Institute and the decision of the President shall be final.
