ICSI-WIRC Half Yearly Program Membership Scheme (PMS) 2023-24

The Western India Regional Council (WIRC) of the Institute of Company Secretaries of India (ICSI) organizes several high-quality professional development programs on contemporary issues and on topics of emerging importance. To facilitate the members to register for the program and get benefits, ICSI-WIRC is pleased to announce its Half yearly Program Membership Schemes "PMS Scheme(s)". The details of the Scheme are as follows:

Credit Hours:

Continuous Professional Education (CPE) Credits would be granted to member(s) attending the program as per the guidelines of the ICSI, wherever so announced by the ICSI-WIRC.

Validity:

The Membership is valid for the period from October 15, 2023 to March 31, 2024.

Annual Fees for PMS:

- 1. WIRC PMS Corporate (includes Partnership / LLP Firm) Membership Scheme (20 CPE PMS Scheme): Member is entitled to get 20 CPE Credits for the payment of Rs.6,000/- plus Goods and Services Tax @ 18% during the validity period of the scheme. In case of more than one member participating in any single program, applicable CPE Credits shall be awarded to such member, and the same shall be considered exhausted from total CPE Credits under this membership plan. Members of this scheme are entitled to attend the programs organized by WIRO as well as Knowledge Centers.
- **2.** WIRC PMS Individual Membership Scheme (10 CPE PMS Scheme) Member is entitled to get 10 CPE Credits for the payment of Rs.3,000/- plus Goods and Services Tax @ 18% during the validity period of the scheme. Members of this scheme are entitled to attend the programs organized by WIRO as well as Knowledge Centers.
- 3. WIRC Andheri Knowledge Center PMS Scheme (Andheri Knowledge Center 10 CPE Credit PMS Scheme)- Andheri Knowledge Center shall arrange to conduct 10 CPE credit program during the validity period of the scheme. Andheri Knowledge Centre membership may be obtained for a Fee of Rs. 3,000/- plus Goods and Services Tax @ 18%. Members of this scheme are entitled to attend the programs organized by Andheri Knowledge Center Only.
- 4. WIRC Mulund Knowledge Center PMS Scheme (Mulund Knowledge Center 10 CPE Credit PMS Scheme)
 - Mulund Knowledge Center shall arrange to conduct 10 CPE credit program during the validity period of the scheme. Mulund Knowledge Centre membership may be obtained for a Fee of Rs. 3,000/- plus Goods and Services Tax @ 18%. Members of this scheme are entitled to attend the programs organized by **Mulund Knowledge Center Only**.

Online Registration & Payment:

Scheme subscription is allowed only by registering through PayU Link and making payment from it. No physical registrations are allowed for subscription. Fees once paid are non-refundable and non-transferable.

Terms and conditions

- 1. This PMS is valid from October 20, 2023 to March 31, 2024. During the validity period, a PMS member is entitled to attend full-day programs/half-day programs/seminars/felicitations arranged by WIRC or by Knowledge Centers, except members of Andheri & Mulund Knowledge Center 10 CPE Credits PMS Scheme. Members of Andheri & Mulund Knowledge Center 10 CPE PMS Scheme are entitled to attend the programs organized by respective Knowledge Centers only.
- 2. PMS members are not entitled to free entry for Joint Programs/ National Level Programs/ Regional or State Conferences of WIRC / Residential Programs / two days Conference/ Workshops / Student Programs / Foundation Day or any other programs specified in the brochure of the program. However, WIRO may, at its sole discretion, from time to time, announce the discount on fees for PMS members for such programs.
- 3. PMS members shall be required to register for a program in advance till the date given in the circular/flyer of the program. Spot registration shall be allowed to PMS Members, strictly on a "**First come: First serve basis**", subject to the availability of seats, however, it is not guaranteed.
- 4. Chairperson, ICSI-WIRC and Chairman, PDC, Mumbai reserves the right to cancel/terminate/change/modify the terms and conditions of the PMS, without any prior notice.
- 5. Fees of PMS once paid are not refundable and subscriptions are not transferable.
- 6. Once the registration of the PMS Scheme is done, then it is deemed to have consented to these terms and conditions of the Individual/Corporate member/Knowledge Center PMS of ICSI-WIRC.
- 7. WIRO reserve its rights to introduce PMS of other Knowledge Centers for the fees to be determined by the WIRO on the same terms and conditions of the Knowledge Center.
- 8. No benefit under any other scheme such as CSBF discount for members shall be applicable to the members/firm subscribing to this scheme.
- 9. Decisions of the Chairman-WIRC and Chairman-PDC, Mumbai shall be final and binding on members with respect to all matters.
