Dear All Students,

The Institute of Company Secretaries of India -Southern India Regional Council is organizing the 20th All India Moot Court Competition -2022 on Saturday, 20th August 2022.

Aurangabad Chapter is organizing the chapter level competition on Saturday, July 16, 2022 physical mode to select for ICSI-WIRC, Regional Level Round tentatively to be held on 31st July, 2022.

Students have to submit the memorials on or before Friday, July 15, 2022 positively

It will be a three tier programme:

- Chapter Level
- Regional Level
- National Level

Aurangabad Chapter would organize Moot Court Competition **Physical Mode** for the students in the Chapter level and send the winning team for Regional Council Level. The Regional Councils will then organize the Moot Court Competition in their Region and send the winning team to participate in the National level event to be organized by ICSI-SIRC.

Note :

Each Chapter can send maximum 2 (two) participants (i.e., 1 as Petitioner and 1 as Respondent) for the Regional Level Competition on the basis of the Preliminary Round held at the Chapter.

National Round:

The Winner and First Runner-up of each Regional Level Competition shall compete in the National Round, which makes the total number of teams to compete at national round to Eight.

Eligibility Criteria:

Participation is restricted to the *bona fide* – registered students of the ICSI. Students will wear their Identity Cards of ICSI during the competition.

Practicing Advocates, Chartered Accountants, Cost Accountants are not eligible to participate and the students of ICSI who have cleared all modules of Professional Programme are not eligible to participate.
