Memorials

The following requirements must be strictly met for each level.
Non-conformities will be penalized:

- Each team must prepare memorials (Petition, Reply, Rejoinder & Written Notes) for both sides, i.e., (Petitioner and Respondent).
- The briefs shall be consistent with the National Company Law Tribunal Rules as amended from time to time.
- Once the memorials are submitted, no revisions, supplements, or additions will be allowed.
- 3 (three) copies each of the memorials for Petitioner & Respondent + a soft copy to be submitted to the respective Chapter / Region in Charge before the two days of commencement of event. Both memorials should be copied in a single CD. Late submission of memorials will not be allowed.
- Memorials must be submitted type written as per National Company Law Tribunal Rules as amended from time to time.
