#### Eligibility Criteria For Admission in CLDP are as under:

To register for 15-days classroom mode CLDP program (residential/non-residential), students must have completed a 15-days online mode CLDP program and have a valid completion certificate. Students eligible for MSOP are also eligible for this CLDP.
