Eligibility Criterion:

1. *Bona fide* -registered students of ICSI shall be eligible to participate in the competition provided they are not having other qualification like CA, LLB, CMA.
2. Students who have passed their Final / Professional CS Exams shall not be eligible to participate in the competition. Participation is restricted to the bona fide registered students of the ICSI. Students will be required to carry their Identity Card of ICSI with them at the competition

Prize:

A Memento/Certificate would be presented to the Winning Team of the above said national event at any forthcoming convocation of ICSI.

National Level Round:

The National Level Round will conduct on Saturday 22nd November at Mumbai, WIRC (wherein teams of all four regions will be participating) to select the All India winners. Winners from Regional Round shall be reimbursed 3AC- train fare to & fro Mumbai.

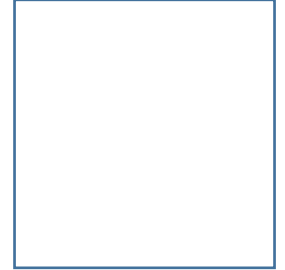
