47<sup>th</sup> National Convention of Company Secretaries on the theme – "Empowering New India: Reform, Perform, Transform" concluded at Jaipur



The three-day 47<sup>th</sup> National Convention of Company Secretaries of the Institute of Company Secretaries of India was inaugurated at Jaipur, Rajasthan on 14<sup>th</sup> November, 2019 and was concluded on 16<sup>th</sup> November, 2019 with much gusto.
