Compliance Certificate by Practising Company Secretary (PCS) for listing of Small & Medium Enterprises (SMEs). In recognition of the role of SMEs in economic development of the country, SEBI and the Stock Exchanges have laid down a conducive regulatory framework for raising resources by SMEs from the market, keeping in view the interests of investors. One critical input is the Compliance Certificate issued by a PCS as per the Guidance Note of the Institute of the Company Secretaries of India (ICSI). According to CS S.N. Ananthasubramanian, President of the Council of the Institute of Company Secretaries of India, the ICSI, in consultation with BSE and the National Stock Exchange of India Ltd (NSEIL), have developed the format of Compliance Certificate to be issued by a Practising Company Secretary (PCS) and also a Guidance Note for their use.
