ORDER

1. The Appellant has filed first appeal on 16.03.2022 under Section 19(1) of the Right to Information Act, 2005 in connection with Response Ref. No. : Registration Number: ICSOI/R/E/22/01211 dated 16.03.2022 against the Central Public Information Officer (CPIO) (hereinafter referred to as Respondent) of the Institute of Company Secretaries of India.
2. The Appellant vide his application dated 27.02.2022 has requested to provide CS Executive Dec 2021 papers.
3. The Appellant has requested in the instant appeals that "I have placed my request related to information from Institute of Company Secretaries of India on 27/02/2022, regarding which I received a mail on 16/03/2022 saying my request has been disposed off . I request you to look at my request as soon as possible and provide me with my information."
4. The reply of the Respondent against the instant appeal is as under: -

"It is submitted that we have provided the requisite information/documents at the email id registered with the ICSI against Roll No 345812 vide Email dated 15.03.2022 in which a web-link, Username and Password have been provided to download and view the answer books. To maintain the privacy of student, the information sought is provided on the registered email id of the student.

In case, Roll No 345812 pertains to some other student, the information sought is exempted under section 8(1) (j) of the RTI Act, 2005.

The contents as above made in the RTI reply stands as it is and are candid.

Therefore, the appeal deserves to be dismissed in-limine.”

5. This Office has carefully considered the application, the response, the appeal and the records made available and finds that the matter can be decided based on the material available on record.
6. This Office concurs with the submission of the Respondent.

The appeal is accordingly disposed of.
