The Company Secretaries Act, 1980 to develop and regulate the profession of Company Secretaries in India. It functions under the jurisdiction of the Ministry of Corporate Affairs, Government of India, with its Headquarters at New Delhi and Regional Offices in Mumbai, Kolkata, New Delhi and Chennai. Besides, there are 72 Chapters across various cities in India. The ICSI on its rolls has over 65,000 qualified members in **Employment and Practice.**

As per Section 203 of the Companies Act 2013 read with Rule 8 & 8A of the Companies (Appointment and Remuneration of Managerial Personnel) Rules, 2014, it is mandatory that every listed company and every other public company having a paid up share capital of Rs. 10 crores or more has to appoint the Company Secretary as whole-time Key Managerial Personnel (KMP). Every private company which has a paid-up share capital of Rs. 10 Crores or more shall have a whole-time Company Secretary.
