

Swami Suparnananda

Justice Ashok Bhushan, Chairman, National Company Law Appellate Tribunal



Mr. Ashok Bhushan is a former Judge of Allahabad High Court, Kerala High Court and the Supreme Court of India. He was the 31st Chief Justice of Kerala High Court.

He graduated from Allahabad University and enrolled with Bar Council of Uttar Pradesh in 1979 and started practising in Civil and Original side at Allahabad High Court till the elevation to the Bench. While practising as an advocate in Allahabad High Court, he served as the standing counsel for various institutions such as Allahabad University, State Mineral Development Corporation Limited and several Municipal Boards, Banks & Education Institutions and also as the Senior Vice – President of the Allahabad High court Bar Association.

He was elevated as permanent Judge of the Allahabad High Court in 2001. He has served as Chairman of Higher Judicial Service Committee and headed several other committees. He was appointed as Judge of the High Court of Kerala in 2014 and appointed as Chief Justice in 2015. In 2016, he was elevated to the Supreme Court of India where he was a judge for five years until his retirement in July 2021.

In his farewell speech organised by the Supreme Court Bar Association, he quoted "Grant of appropriate remedy is not the discretion of the judge but his obligation. Justice must be tempered with mercy but justice cannot be substituted for mercy."

Shri Rajsekhar VK is a law graduate from Delhi University. Prior to his appointment as Judicial Member, NCLT, he was selected and appointed as Panel Counsel for Institute of Chartered Accountants of India (ICAI) for courts in and around Chennai.
