

Nominee in the Governing Council of the ICSI, Independent Director of ICAI Registered Valuers Organization and Professor of Practice-Law & Finance at Jamia Hamdard, New Delhi. He retired in 2023 as Technical Member, NCLAT, Principal Bench, New Delhi on elevation from Technical Member, NCLT, Bangalore through high powered Search-cum-Selection Committee constituted by Hon'ble Chief Justice of India and Government of India.

He has over 40 years of extensive professional experience across various levels of Central and State Governments including quasi-government entities in accounting, financing, contract management, liasoning and legal domain. He led resolution of major litigation with governments of states of Karnataka and Orissa involving financial liability in excess of ~ \$2B that had been pending in various judicial forums for 15 to 20 years, resolving them through Alternate Dispute Resolution with settlement under \$500M & at the minimum tax rate/tax exemption for future.
