Shanghai Cooperation Organization (SCO)*

Introduction

The Shanghai Cooperation Organisation (SCO) is a permanent intergovernmental international organisation founded in Shanghai, China on 15 June 2001.

The main goals of the SCO are strengthening mutual confidence and good-neighbourly relations among the member countries; promoting effective cooperation in politics, trade and economy, science and technology, culture as well as education, energy, transportation, tourism, environmental protection and other fields; making joint efforts to maintain and ensure peace, security and stability in the region, moving towards the establishment of a new, democratic, just and rational political and economic international order.

Proceeding from the Spirit of Shanghai, the SCO pursues its internal policy based on the principles of mutual trust, mutual benefit, equal rights, consultations, respect for the diversity of cultures and aspiration towards common development, its external policy is conducted in accordance with the principles of non-alignment, non-targeting anyone and openness.

The SCO currently comprises eight Member States (China, India, Kazakhstan, Kyrgyzstan, Russia, Pakistan, Tajikistan and Uzbekistan), four Observer States interested in acceding to full membership (Afghanistan, Belarus, Iran, and Mongolia) and six "Dialogue Partners" (Armenia, Azerbaijan, Cambodia, Nepal, Sri Lanka and Turkey).

The historical meeting of the Heads of State Council of the Shanghai Cooperation Organisation was held on 8-9 June 2017 in Astana. In the meeting the status of a full member of the Organization was granted to the India and Pakistan.

In 2021, the decision was made to start the accession process of Iran to the SCO as a full member, and Egypt, Qatar as well as Saudi Arabia became dialogue partners.

The SCO has been an observer in the UN General Assembly since 2005. In April 2010, the UN and SCO Secretariats signed a Joint Declaration on Cooperation.

The Council of Heads of State

The SCO Heads of State Council shall be the supreme SCO body. It shall determine priorities and define major areas of activities of the Organisation, decide upon the fundamental issues of its internal arrangement and functioning and its interaction with other States and international organisations, as well as consider the most topical international issues.

The Council shall hold its regular meetings once a year. A meeting of the Heads of State Council shall be chaired by the head of State organising this regular meeting. The venue of a regular meeting of the Council shall generally be determined in the Russian alphabetic order of names of the SCO member states.

SCO Secretariat

The SCO Secretariat, based in Beijing, is the main permanent executive body of the SCO. Bringing together the colourful and distinctive cultures of Central and South Asia, China and Russia, it promotes mutual assistance and team spirit among staff and provides reliable support on the basis of a stable administrative system that has taken shape over 15 years.

The Secretariat is headed by the Secretary-General. Nominated by the Council of Ministers of Foreign Affairs and approved by the Heads of State Council, the Secretary-General is appointed from among citizens of the SCO member states on a rotating basis in Russian alphabetical order for a single three-year term with no possibility of extension. Deputy Secretaries-General are nominated by the Council of National Coordinators and approved by the Council of Ministers of Foreign Affairs. Officials of the Secretariat are hired from among citizens of the SCO member states on the basis of quotas.

The SCO Secretariat coordinates the activity of the SCO and provides informational, analytical, legal, organisational and technical support. Russian and Chinese are the official working languages of the SCO.

India to host SCO Summit 2023

The rotational presidency of the Shanghai Cooperation Organization has been handed over to India in Samarkand, Uzbekistan. Delhi will hold the presidency of the grouping for a year until September 2023. And next year, India will host the SCO Summit.

During the SCO Summit in Samarkand, Uzbekistan held between 15 and 16 September 2022, the Member States noted that the various global challenges and threats including technological and digital divide, continued turbulence in global financial markets, instability in supply chains, increased protectionist measures and uncertainty in the global economy.

In the Samarkand Declaration, the member states supported the efforts of the countries of the region to ensure prosperity, peace and sustainable development. They advocated strengthening the role of SCO in enhancing stability and socio-economic development in the region.

The city of Varanasi has been nominated as the first-ever SCO Tourism and Cultural Capital during the period 2022-2023 at the 22nd Meeting of Shanghai Cooperation Organization (SCO) Council of Heads of State in Samarkand, Uzbekistan on September 16, 2022.

The nomination of Varanasi as the first ever SCO Tourism and Cultural Capital will promote tourism, cultural and humanitarian exchanges between India and the SCO member Countries. It also underlines India's ancient civilizational links with Member States of SCO, especially the Central Asian Republics.

Release of wild Cheetahs in Kuno National Park in Madhya Pradesh (September 17, 2022)

The Prime Minister on September 17, 2022 released wild Cheetahs which had become extinct from India at Kuno National Park in Madhya Pradhesh. Cheetahs which were brought from Namibia are being introduced in India under Project Cheetah, which is world's first inter-continental large wild carnivore translocation project. Out of the eight Cheetahs there are five female and three male Cheetahs.

The release of wild Cheetahs by the Prime Minister in Kuno National Park is part of his efforts to revitalise and diversify India's wildlife and its habitat. The cheetah was declared extinct from India in 1952. The Cheetahs that were released are from Namibia and have been brought under an MoU signed earlier this year.

Cheetahs will help restore open forest and grassland ecosystems in India. This will help conserve biodiversity and enhance the ecosystem services like water security, carbon sequestration and soil moisture conservation, benefiting society at large. This effort, in line with the Prime Minister's commitment to environmental protection and wildlife conservation, will also lead to enhanced livelihood opportunities for the local community through eco-development and ecotourism activities.

Launch of National Logistics Policy (September 17, 2022)

The Prime Minister, Shri Narendra Modi launched the National Logistics Policy (NLP) at Vigyan Bhawan, New Delhi on September 17, 2022. National Logistics Policy, a comprehensive effort to address issues of high cost and inefficiency by laying down an overarching interdisciplinary, cross-sectoral and multijurisdictional framework for the development of the entire logistics ecosystem, is yet another step in this direction. The policy is an endeayour to improve competitiveness of Indian goods, enhancing economic growth and increasing employment opportunities. The PM GatiShakti - National Master Plan for mutimodal connectivity - launched last year, was a pioneering step in this direction. PM GatiShakti will get further boost and complementarity with the launch of National Logistics Policy.

 Merger of metal companies of Tata Group with Tata Steel (September 23, 2022)

In a bid to drive efficiency and cut operational cost, Tata Steel has decided to merge seven subsidiaries, including four listed entities with itself. The Board of Directors of all the Tata Steel group companies have approved the schemes for the proposed amalgamation. Those seven metal companies of Tata group that will be merged with Tata Steel are Tata Steel Long Products Limited, The Tinplate Company of India Limited, Tata Metaliks Limited, TRF Limited, The Indian Steel & Wire Products Limited, Tata Steel Mining Limited and S & T Mining Company Limited.

The subsidiaries are all majority owned by Tata Steel and include Tata Steel Long Products (74.91 per cent equity holding), The Tinplate Company of India (74.96 per cent), Tata Metaliks (60.03 per cent), The Indian Steel & Wire Products (95.01 per cent), Tata Steel Mining and S&T Mining Company (both wholly owned subsidiaries). TRF Ltd, which is 34 per cent owned by Tata Steel, is termed as associate company.

Each scheme of amalgamation will now move into a defined regulatory approval process, which includes approval by stock exchanges and the NCLT. Based on independent valuer report, Tata Steel Long Products investors will get 67 shares of Tata Steel for every 10 shares held. Similarly, for every 10 shares of the Tinplate Company of India, 33 shares of Tata Steel will be issued. Ten shares of Tata Metaliks will fetch 79 shares of Tata Steel and TRF Ltd investors will get 17 shares of Tata Steel for every 10 shares held.

The proposed amalgamation is a part of Tata Steel's initiative to simplify the group holding structure. Since 2019, Tata Steel has reduced 116 associated entities. Its 72 subsidiaries have ceased to exist, 20 Associates and JVs have been eliminated and 24 companies are currently under liquidation.
