**Q This test portal is compatible on which browsers?**

A. the Portal is best viewed in Mozilla Firefox 37 and Google Chrome 44 and above.

**Q. What are the preferred screen resolutions for best viewing?**

A. The preferred screen resolution is of width 1024px to 720px and above.

**Q. Can the test be taken without internet?**

A. Internet Connectivity is prerequisite for using ICSI portal. Offline version is not applicable.

**Q What are the required guidelines for the browser for launching the assessment?**

A. Please enable Popup on the browser, Cookies should be enabled and zoom level should be 100 %.
