In addition to making available the result along with subject-wise break-up of marks on the Institute's website - www.icsi.edu, the ICSI has extended the facility of downloading of e-Result-cum-Marks Statement by the Examinees of Executive Programme Examination.

In Professional Programme Examination (Syllabus – 2022) **32.69** percent of Candidates passed in Group– 1 and **29.49** percent in Group – 2.
