Re-Registration to Professional Programme

Eligibility criteria

The Re-Registration Policy is meant to welcome back students who have passed Intermediate Course or Executive Programme of CS Course under any previous syllabus but not eligible for seeking Registration Denovo due to the reason that the stipulated period has expired. Such students are not required to start afresh from Executive Programme Stage. Instead, they can Re-Register directly to the Professional Programme and continue their journey towards becoming a Company Secretary.

ICSI STUDENTS AMNESTY SCHEME – 2025

Rejoin. Restart. Rebuild Your CS Journey.

The Amnesty Scheme is intended to encourage the following categories of students to rejoin the CS Course / avail additional exemptions by paying a nominal fee.

Category – 1

Eligibility Criteria

- Earlier Students of Intermediate / Executive Programme Stage OR Final / Professional Programme Stage; and
- Registrations expired and not eligible for Registration Denovo

Fee: ₹ 5,000

Applicable Syllabus 2022

- 5-years registration validity
- Corresponding Exemptions as applicable in case of De-novo
- TDOP Exempted
- Study Material on remittance of requisite cost separately.
- Pre-Exam Test to be completed after paying the Pre-Exam Test Fee to become eligible for Examination Enrollment.

Category – 2

Eligibility Criteria

- Existing Students of Executive Programme under Syllabus 2022; and Registered afresh in Executive Programme after expiry of former registration, as they were not eligible for Registration Denovo
- OR
- Existing Students of Professional Programme under Syllabus 2022; and Registered in Professional Programme after expiry of former registration, through Re-Registration.

Fee: ₹ 1,000

Applicable Syllabus 2022

- 5-year registration validity remains same from the date of Fresh Registration OR Re-registration
- Additional Exemptions as per revised mapping from earlier syllabus
- TDOP applicability as per guidelines prevalent at the time of fresh Executive registration
- Study Material on remittance of requisite cost separately, if required
- Pre-Examination Test completion required before exam enrollment

Scheme Duration:

- From 1st December 2025 to 28th February 2026.
- No applications shall be entertained after the closure date of the Amnesty Scheme.

Student Induction Programme (SIP)

Designed to familiarize the students with CS course and profession, all students registering for CSEET on or after 16th December, 2025 are required to undergo one day SIP, within one month of registration.



Three day Orientation Programme (TDOP)

All students registering for CS Executive on or after 1st February 2025 are required to undergo three days orientation programme, within three months of registration.

Corporate Leadership Development Program (CLDP)



Alternative Method for working Professionals

Students who are working Professionals and have been granted Full Exemption / passed CS 5 years prior to date of application, may complete 30 days / 15 Days CLDP through Alternative method through online mode or weekend classes.



Revision in the manner and mode of undergoing 30 days CLDP

CLDP Phase I - 15 days CLDP Classroom Mode (Non-Residential) and CLDP Phase II - 15 days CLDP Classroom Mode (Residential). w.e.f. 15th December, 2025.



Allotment of Associate Membership upon completion of 30 days Corporate Leadership Development Programme (CLDP)

eligible students are now allotted their Membership Number on the last day of CLDP Phase II - 15 days CLDP in Classroom mode (Residential) and 30 days/15 days in Online Mode (Alternative Method).

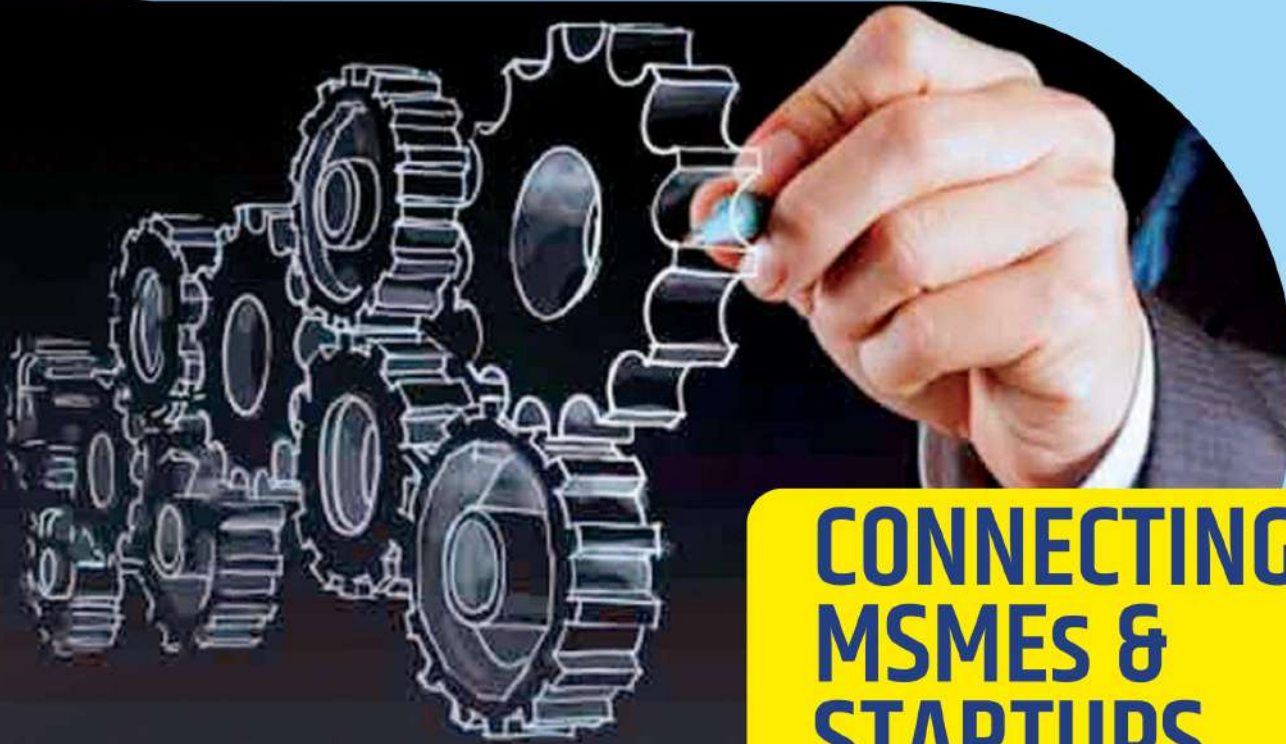

MAJOR AMENDMENTS

Allocation of Structured and Unstructured CPE Credits to different Learning Activities clearly defined.

Carry-forward of Structured CPE Credits (upto 8 credits) to next financial year permitted (subject to fulfilment of mandatory requirement of 20 CPE credits in current year).

Proportionate CPE credits to participants who attend the Programme partially.

Members above 60 years (in gainful employment relating to CS profession or holding COP) : 10 CPE Credits (**structured or unstructured**).

Entrepreneurs : 10 CPE Credits (through any mode either (Structured or Unstructured)

CONSEQUENCE OF NON-COMPLIANCE

A member not able to obtain requisite **Structured CPE Credits** in the current year shall obtain double the remaining Structured CPE Credits in the next year along with the annual mandate.

E.g.: CPE obligation for FY 2026-27: 20 CPE Credits

CPE obtained in FY 2026-27 (including extended period, if any): 12 CPE (4 S + 8 US)

CPE required to be obtained in FY 2027-28 (including extended period, if any): $20 + (2 \times 4)$ CPE = 28 CPE

Restructuring of Company Secretary Executive Entrance Test (CSEET)

The **Company Secretary Executive Entrance Test (CSEET)** is the entry-level qualifying exam for students who want to join the CS Executive Program, conducted by the **Institute of Company Secretaries of India (ICSI)**. CSEET is a computer-based entrance examination conducted through remote proctored mode till January 2026.

Starting from the **June 2026 session**, ICSI has restructured the exam format and syllabus.

The restructured CSEET for the June session onwards moves away from the existing 120-minute MCQ- format to a more comprehensive evaluation:

The subjects and pattern of restructured CSEET shall be as under:-

Subjects	Maximum Marks	Pattern	Duration
Business Communication	100	Subjective	3 Hours
Fundamentals of Accounting	100	Subjective	3 Hours
Economic and Business Environment	100	Subjective	3 Hours
Business Laws and Management (Business Laws- 60 Marks) (Business Management- 40 Marks)	100	OMR BASED	2 hours

The offline mode, being introduced from the June 2026 session, is designed to align with the professional standards of the CS Executive and Professional levels.

Zero Technical Anxiety

Students don't have to worry about their internet connection dropping, power cuts at home, or software crashing mid-exam.

Focus & Discipline

A designated exam center provides a controlled, quiet, and professional environment that minimizes household and other distractions.

Structured Format:

The new offline pattern allows for subjective answers, giving students a chance to earn marks for their conceptual understanding and presentation, rather than just choosing a correct MCQ option.

Verification & Review

Unlike the online mode, the offline restructured exam allows students to apply for Verification of Marks or request Certified Copies of their answer sheets.

Better Foundation

By testing subjective writing skills, the offline exam better prepares Students for the rigorous descriptive papers of the CS Executive Programme.

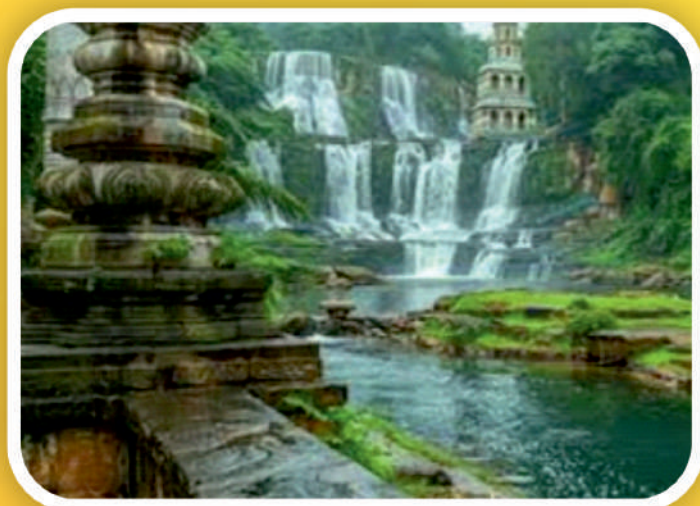

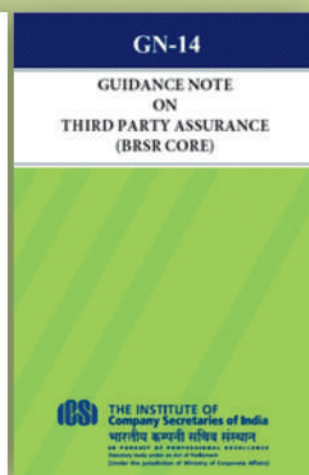
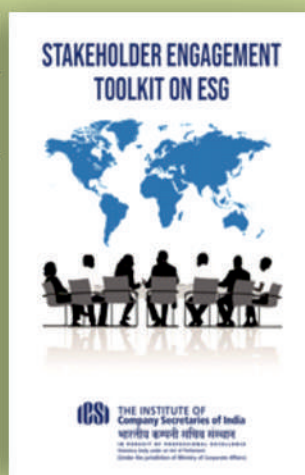
