ORDER

- (1) The Appellant has filed first Appeal- No. ICSOI/A/E/24/00038 on 20.03.2024 under Section 19(1) of the Right to Information Act, 2005 in connection with Response Ref No. ICSOI/R/E/24/04763 dated 13.03.2024 against the Central Public Information Officer (CPIO) (hereinafter referred to as Respondent) of the Institute of Company Secretaries of India.
- (2) The Appellant vide his application dated 29.02.2024 has requested to provide scanned certified copies of answer sheets of CS Executive Dec 2023 examination for the subjects: JURISPRUDENCE INTERPRETATION AND GENERAL LAWS. 2. COMPANY LAW 3. SETTING UP OF BUSINESS ENTITIES AND CLOSURE 4. TAX LAWS.
- (3) The Appellant has informed in the instant appeal that "Provided Incomplete, Misleading or False Information".
- (4) The reply of the Respondent against the instant appeal is as under: -

"It is submitted that the requisite information as sought by the Applicant (Appellant hereinafter) in his RTI Application ICSOI/R/E/24/04763 dated 29.02.2024, is in public domain and freely available without any cost at link <https://cc.icsi.edu>.

Further, the Appellant was informed about the said link and the procedure to fetch the information in response to his above mentioned RTI Application vide letter dated 13.03.2024 which was accessed by the Appellant (copy of screen shot attached).

Furthermore, it is to be informed that the information provided to the Appellant is complete in all respects i.e. the complete scanned copies have been supplied to the applicant and not only the marks, as stated by the Appellant (copy of screen shot attached).

The contents as above made in the RTI reply stands as it is and are candid".

(5) This Office has carefully considered the application, the response, the appeal and the records made available and finds that the matter can be decided based on the material available on record.

The requisite information as sought by the Applicant was freely available in public domain without any cost at link <https://cc.icsi.edu> as intimated by CPIO EXAM to the appellant vide communication dated 13.03.2024.

Further, CPIO EXAM has substantiated that Appellant has already accessed the required information through the above-mentioned portal.

The appeal is accordingly disposed of.
