ORDER

- (1) The Appellant has filed first Appeal- No. ICSOI/A/E/24/00042 on 26.03.2024 under Section 19(1) of the Right to Information Act, 2005 in connection with Response Ref No. ICSOI/R/E/23/05558 dated 13.03.2024 against the Central Public Information Officer (CPIO) (hereinafter referred to as Respondent) of the Institute of Company Secretaries of India.
- (2) The Appellant vide her application dated 03.03.2024 has requested to provide the certified copies for CS Professional December 2023 examination for Module 2 subjects i.e 1. Secretarial audit (SACMDD) 434 2. Corporate restructuring (CRILW) 435 3. Resolution of corporate dispute (RCDNR) 436.
- (3) The Appellant has informed in the instant appeal that “Provided Incomplete, Misleading or False Information”.
- (4) The reply of the Respondent against the instant appeal is as under: -

“It is submitted that the requisite information as sought by the Applicant (Appellant hereinafter) in her RTI Application ICSOI/R/E/24/05558 dated 03.03.2024, is in public domain and freely available without any cost at link <https://cc.icsi.edu>.

Further, the Appellant was informed about the said link and the procedure to fetch the sought information vide letter dated 13.03.2024(copy of letter enclosed). An announcement in this regard has also been published on the website of the Institute

(copy of announcement attached).

Furthermore, it is to inform that Appellant has already accessed the required information through the above mentioned portal (copy of screen shot attached).

The contents as above made in the RTI reply stands as it is and are candid”.

- (5) This Office has carefully considered the application, the response, the appeal and the records made available and finds that the matter can be decided based on the material available on record.

The requisite information as sought by the Appellant was freely available in public domain without any cost at Link <https://cc.icsi.edu> as intimated by CPIO EXAM to the appellant vide communication dated 13.03.2024.

Further, CPIO EXAM has substantiated that Appellant has already accessed the required information through the above-mentioned portal.

The appeal is accordingly disposed of.
