- (1) The Appellant has filed first Appeal- No. ICSOI/A/E/24/00052 on 8.04.2024 under Section 19(1) of the Right to Information Act, 2005 in connection with Response Ref No. ICSOI/R/E/24/06923 dated 08.04.2024 against the Central Public Information Officer (CPIO) (hereinafter referred to as Respondent) of the Institute of Company Secretaries of India.

 - 3. If no response received, what further action will be taken against Sh. Dhiraj Kapoor, FCS-5454 & Ms. Neerja Sharma, ACS-9630.
- (3) The Appellant has informed in the instant appeal that "Provided incomplete, misleading or false information".
- (4) The reply of the Respondent against the instant appeal is as under: -

"The written submission of the Respondent is as under:-

Since the RTI application pertains to Directorate of Discipline of the ICSI, therefore, the CPIO has asked for written submission from concerned Directorate for the same. Their submission is mentioned below:

The Complainant, Mr. Harsh Vig (Appellant herein) has filed two separate complaints of professional or other misconduct against Shri Dhiraj Kapoor, FCS-5454 (DC/1031/2024) and Ms. Neerja Sharma, ACS-9630 (DC/1032/2024). Both these complaints are under investigation pursuant to the Company Secretaries Act,1980 (the Act) read with the Company Secretaries (Procedure of investigations of professional and other misconduct and conduct of cases) Rules, 2007 (the Rules). Pursuant to Act and Rules, the copies of written statements received from Shri Dhiraj Kapoor, FCS-5454 and Ms. Neerja Sharma, ACS-9630 in the respective complaints have been sent to the Complainant.

Since the Appellant has been provided the copies of the written statement received from Shri Dhiraj Kapoor and Ms. Neerja Sharma, the appeal has been infructuous and have deserves to be dismissed.
