



FAQs on Certificate Course on Forensic Audit

Q1. What is the eligibility qualification for the Course?

A1. Eligibility Qualification for the course is as under :

- (a) Members of ICSI
- (b) Student of ICSI who have qualified CS Executive Programme or higher

Q2 How will the course be delivered?

A2. The Course will be delivered through the Learning Management System of the ICSI.

Q3. How can I access the LMS?

A3. Candidates' login id and password on LMS to access the course content, will be emailed to them immediately upon their registration to the course. Guide to LMS login is available at <https://www.icsi.edu/certificate-course/>

Q4.What is the Course Duration ?

A4.Course duration is one month excluding online examination.

Q5. Will we get the study material or lectures?

A5. Yes, study material will be provided in soft copy. It would be available on LMS once the course commence. Also, live webinar lectures on every Friday and Saturday of 3 hours each will be conducted. Candidates may also view the same (recorded lectures) subsequently on their LMS Account.

Q6. How much time and involvement will be needed for this course from my day-to-day schedule?

A6.The course being an online course and has no classroom attendance requirement, you can decide when you wish to study the course material. On an average, if you can spend two-three hours per week studying the course modules besides watching the course videos/webinars, you will be able to pursue the course comfortably with the rest of your professional responsibilities.

Q7. When will the Course commence?

A7. The Course will commence within 10 days of the closure of registration. Details about course commencement will be updated on the LMS.

Q8. What will be the mode of delivery- online or offline?

A8.The course will be delivered in online mode through ICSI- LMS.

Q9. Is there any attendance requirement?

A9. No

Q 10. What will be the assessment and evaluation mechanism?

A10. Online MCQ based examination on pre-decided and pre-informed dates will be the evaluation mechanism under the course. These dates will be mentioned on your course calendar once you become part of the course

Q11. Whether the Examination will be conducted at fixed centers?

A11. No, candidates can appear in the online exam from anywhere through internet connectivity.

Q12. Will there be any negative marking in the exam?

A12. There will not be any negative marking in the online examination?

Q13. Whether out of India candidates also eligible to apply for the Course?

A13. Only Indian citizens living abroad can apply for the course. However, the online examination of the course will be conducted as per the Indian Standard Time (IST) only.

Q14. What are the job opportunities after completing this Course?

A14. The Forensic Audit course will equip the candidates to develop skills required to tackle corporate fraud and other allied areas in Forensic Advisory. Candidates can avail this learning opportunity for entry/growth in functions such as Accounting Firms (Forensic and Investigation dept.), Corporate (Risk and compliance dept.) , law firms etc.
