




CS Manoj Banthia


Ms. Shivani Agarwalla TedX Speaker, 5 times World Kettlebell Champion & Chartered Accountant



Ms. Shivani Shah Agarwalla is an Indian sportsperson and Chartered Accountant who is widely acknowledged as the first Indian woman to become a world champion in Kettlebell sports. She represented India at the International Kettlebell World Championship at Uzbekistan in 2018, winning the first gold medal for India in that category. She further outclassed her own achievements in 2019, when she won the 2nd gold medal in Australia followed by the 3rd gold medal in France last year, November 21'. She won Double Gold for India at the 29th IGSF World Championship held at Greece in July 2022 where she got the coveted rank of Master of Sports which is the first by any Indian Woman Athlete.

She is India's only 5 time Woman World Champion in Kettlebell Sports. She has been instrumental in building India's robust positioning in Kettlebell, and the same has been acknowledged by the Indian Government. Her achievements and efforts to bring glory to the nation have been acknowledged by the Hon'ble Prime Minister of India, Shri Narendra Modi Ji who sent a letter of appreciation to her father, recognising her contribution to nation building by winning gold for the country.

Besides Kettlebell, she is a renowned Chartered Accountant, a practicing member and National Faculty for Indirect Taxation from the ICAI, having delivered 250+ sessions on the subject of Indirect Taxation across the country. She garnered a lot of praise for her recent TedX speech as well, something that she delivered back in December 21'. She was conferred the Pride of Bengal Award 2022 alongside the likes of Arnab Goswami, Leander Paes, Arup Raha. Despite having a distinguished career as a Practicing Chartered Accountant, she went on to pursue her passion in sports and that has made all the difference. Time and again, she has been vocal about the need to promote new form of sports and how the recognition from the ministry and the government will go a long way in pushing more people to pursue their passion and break free from the age old stereotypes of sticking to the basics.

Leadership Coach, Assessor & Facilitator, POSH & HR Consultant




